## Significant Facts

---

- **The probability of being a victim of a Part 1 crime in the Metro system is 2.79 per million customers.**
- In 2008, the MTPD received 54,972 calls for service, made 1,609 arrests, issued 5,760 criminal/civil citations and wrote 2,622 fare evasion citations.
