NARRATIVE

The current contract, one-year base with two one-year options, expires June 30, 2006. This action is to initiate a competitive procurement for the printing of daily-dated regional bus-to-bus transfers and regional one-day passes. It contains a rider agreement that permits local transit providers to purchase the fare media directly from the contractor at the Authority's rates.

The Board approved the regional bus transfer arrangement with local transit systems to improve regional fare integration. Regional transfers are used to permit passengers to continue a trip when the use of more than one bus, Metrobus or participating transit system's bus, is required to complete a trip. Regional one-day passes allow all-day transfers on regular bus routes, except for a step-up charge on express routes. The use of regional bus-to-bus transfers and regional one-day passes support the regional fare simplification program.

Over the next year, it is anticipated that SMARTRIP fareboxes will be installed on all regional buses. Staff will be coming forward at that time to discuss options on Bus to Rail transfers and possible elimination of paper bus transfers in lieu of SMARTRIP Bus to Bus transfers.
