DESCRIPTION			
SUBJECT:	Modification of the paratransit services contract, C-05108		
PURPOSE:	To request Board approval to modify the paratransit services contract, C-05108, with MV Transportation, Inc. in the amount of \$1,096,956 to retain 77 vehicles for continued use in the dedicated fleet, and purchase the requisite number of Mobile Data Computers (MDCs), DriveCams, and radios for full communication and performance tracking capability as well as necessary insurance coverage. Additionally, two extra dispatchers will be needed to monitor the movement of these 77 vehicles. The additional vehicles, which a majority of them are wheelchair accessible, are needed to meet demand based on actual trip data and current demand patterns. Also, the additional vehicles will reduce the dependability on taxis. The additional wheelchair accessible vehicles should improve the reliability of the paratransit service.

NARRATIVE

DISCUSSION

In September 2005, WMATA awarded a new contract to provide paratransit services in the Washington metropolitan area to MV Transportation, Inc. On January 14, 2006 Logisticare completed its contract and MV Transportation began operations on January 15, 2006. The contract with MV requires the operation of 255 vehicles to meet the projected FY06 demand of 1.45 - 1.6 million trips. WMATA based that requirement on trip data provided by Logisticare through Emtrack, their reservation and scheduling software. Emtrack could not provide peak period vehicle requirements, so an estimate was included in the RFP and resulting contract.

MV Transportation used their automated reservation and scheduling software, Trapeze, to analyze trip data and demand patterns. The analysis of the current MetroAccess trip data and demand patterns revealed that 255 vehicles would be insufficient to meet the weekday peak demand between the hours of 7:00 a.m. and 10:00 a.m. and 3:00 p.m. and 6:00 p.m. During these periods, a total of 332 vehicles are required to meet demand. Maintaining the fleet size at 255 vehicles increases the reliance on taxi trips from 5% to about 14% (or an increase of about 440 taxi trips per weekday or 112,200 taxi trips annually).

This action does NOT require the purchase of an additional 77 vehicles. The fleet currently in operation has 77 vehicles in reasonably good condition that may be retained for service for a year or so. Staff will revisit the vehicle requirement after the new service has stabilized. However, the 77 vehicles retained for service need to be equipped with Mobile Data Computers/Automated Vehicle Locators, radios, and on-board cameras, in order to ensure that those vehicles can be properly monitored for on-time performance and service quality, as required by the contract. The vehicles need to be insured, and two additional dispatchers will be needed to properly monitor the vehicles and trip activity. The total cost for these items is \$1,096,956. Final costs are subject to negotiation and audit. Due to the higher than anticipated peak demand, it is possible that additional service hours may need to be operated; the number of additional hours and associated costs, if any, will be established after the transition is fully implemented. When the 77 vehicles are taken out of service, the MDCs, radios, and cameras can be removed from these vehicles and placed in new vehicles purchased.

ALTERNATIVE

Maintain the current fleet size of 255 vehicles and increase the reliance on taxi trips from 5% to 14%, an increase of 440 taxi trips per weekday or 112,200 taxi trips annually, at an estimated cost of \$2.2M. Federal regulations require that WMATA provide continuous and uninterrupted service.
