WMATA''s new Bus and Rail Scheduling systems utilize the Trapeze software being implemented under the Information Technology Renewal Program (ITRP) for the Authority.

This contract provides for the continuation of services from Trapeze Software Group, Inc for providing site license software and maintenance for its use throughout the Authority. The current contract expires on April 1, 2006.

This software is obtained through an annual Site License and Maintenance Agreement which also provides technical support and access to software upgrades.

These services are available through the GSA IT Schedule and discounts below list price are based on the usage volume of an organization.

#### **ALTERNATIVES:**

Trapeze holds proprietary rights on its software packages and maintenance. Continuation of the required services can only be provided by Trapeze Software Group, Inc.
