NARRATIVE

DISCUSSION:

WMATA's new Maintenance and Materials Management System (MMMS) utilizes the MRO software being implemented under the Information Technology Renewal Program (ITRP) for the Authority.

This contract provides for the continuation of services from MRO Software, Inc. for providing site license software and maintenance for its use throughout the Authority. The current contract expires on April 1, 2006.

This software is obtained through an annual Site License and Maintenance Agreement which also provides technical support and access to software upgrades.

These services are available through the GSA IT Schedule and discounts below list price are based on the usage volume of an organization.

ALTERNATIVES:

MRO holds proprietary rights on its software packages and maintenance. Continuation of the required services can only be provided by MRO Software, Inc.

For the base year and the four option periods, the total estimated cost of this procurement is \$1,469,874. This amount is based upon estimated requirements and availability and approval of annual funding subject to Board approval of the fiscal year budgets and availability of funds.

RECOMMENDATION:

the four one-year options with not to exceed values in FY2008 through FY2011 of \$285,021, \$293,571, \$302,378, \$312,185 respectively, subject to Board approval of the fiscal year budgets and availability of funds.
