#### TITLE:

FY2010 Annual DBE Program Goal

#### PURPOSE:

The purpose of this action is to seek approval of the 45-day period for public comment regarding the proposed Annual Disadvantaged Business Enterprise (DBE) program goal for Federal Fiscal Year 2010. This is in compliance with the Federal Transit Administration (FTA) regulations for federally-funded recipients, which require a public comment period prior to final adoption of the annual goal.

#### **DESCRIPTION:**

The U.S. Department of Transportation (USDOT), under 49 CFR, Part 26, requires all recipients of federal funds to establish an annual goal for DBE participation on federally-funded contracts. Metro will be informing the public of the proposed goal of 25% by holding a public comment period from May 28 to July 13, 2009. There will be a public meeting on June 30, 2009. Staff used guidelines developed by the USDOT to calculate the annual goal. The empirical data was generated from the 2002 U.S. Census data on businesses.

#### **FUNDING IMPACT:**

The FTA requires an annual DBE goal as part of the certications and assurances necessary to receive grant funding.



# **Purpose**

- Seeking approval to initiate a 45-day public comment period on the proposed 2010 Disadvantaged Business Enterprise (DBE) goal
- Public comment is required by the Federal Transit Administration

# **Federal Requirements**

- Under Federal Regulation (49 CFR26) recipients of federal transportation funds must submit an annual DBE Goal by August 1
- FTA requires DBE goal as part of annual certifications and assurances necessary to receive grant funding





# **Proposed Goal**


Proposed 2010 DBE Goal is 25% of the anticipated federally-supported contracts awarded by Metro in FY 2010

- •19% of Goal to Be Achieved by setting project-specific goals for DBEs
- 6% of Goal to be Achieved through other means, including:
  - Encouraging the use of DBEs on Metro projects, without the use of projectspecific goals
  - Supporting efforts to assist DBEs to become prime contractors on Metro Projects
  - Continued participation in various business development and outreach programs geared towards enhancing the capacity of Metro DBEs to participate in Metro contracts

\*Figures expressed for FY09 reflect the anticipated DBE Procurements. Data on actual achievement will not be available until the end of the fiscal year.

Also, DBE goals for contracts funded by the American Recovery and Reinvestment Act are excluded here and are calculated separately. Those calculations are also reported to FTA.

# **Appendix A - The FTA Goal Formula Process**

Step 1 – Calculate the Base Figure

Step 2 – Adjust Base Figure (Historical attainment)

Step 3 – Calculate Race Conscious/Race Neutral Percentage

Race Conscious = A specific DBE goal is assigned to a contract

Race Neutral = No DBE goal is assigned to a contract



# Appendix A - The FTA Goal Formula Findings

The ultimate goal of the program is to move to a Race Neutral environment. Metro has been able to increase its Race Neutral Goal because:

- 1) Metro continues to exceed its overall annual goal; and
- 2) More DBE vendors are winning Metro contracts as prime contractors
