TITLE:

FY10 Work Program

PURPOSE:

(A) Authorize the FY10 annual work programs for two "On-Call" engineering services contracts. (B) Amend the FY09 authorization for "On-Call" Consulting Contract No. SF5070 for construction management costs for the fully-reimbursable project, Glenmont II Parking Structure construction contract.

DESCRIPTION:

(A) FY10 annual work program for two engineering services contracts: These contracts are to perform engineering projects included in proposed FY10 budget and/or are from prior years. The approval process for "On-call" engineering services contracts is in compliance with the procedure followed during the past several years.

The requested monies will be utilized primarily to fund consultant design and support tasks for the continuing Metro Matters Program, urgent unfunded needs, and other non-Metro Matters support tasks for Dulles Extension and Joint Development.

(1) General Architectural and Engineering Services Contract

This is the fifth year of a five-year contract for "On-Call" General Architectural and Engineering Services with a joint venture consisting of Parsons Transportation Group, Parsons Brinckerhoff Quade and Douglas, and Delon Hampton and Associates (P2D). The estimated cost for the FY10 annual work program is \$14,143,000.

(2) Planning, Architectural, and Engineering Services for Future `New Starts` Projects Contract

This is the fifth year of a five-year contract for "On-Call" Planning, Architectural, and Engineering Services for future `New Starts` Projects to DMJM Harris, Inc. The estimated cost of FY10 annual work program is \$4,800,000.

(B) An amendment to approved FY09 authorization for "On-Call" Consulting Contract (SF5070):

This amendment is in the amount of \$1.9M to include construction management of the fullyreimbursable project, Glenmont II Parking Structure. On April 3, 2009, the construction contract was awarded to the Forrester Construction Company and issuance of the notice-to-proceed is pending execution of project documents and bonding requirements. Per Metro s present approach, the construction management efforts, including review of contractor submittals, project administration and response to request for information and so on, will be provided externally.

FUNDING IMPACT:

Funds for the engineering contracts mentioned under **(A)** in the description are from prior years and/or are proposed in the FY10 Annual Budget subject to Board approval of the budget and availability of funds.



Purpose

 - The amendment of the FY09 authorization for an "On-Call" Consulting Contract in the amount of \$1.9M for Construction Management Costs for the fully-reimbursable contract, Glenmont II Parking Structure.



Benefits/Savings

Benefits

- Metro will benefit by avoiding staffing necessary to support the work covered under these contracts.
- Contracts provides specialized Professional Services to augment inhouse staff.

Savings

- Savings by eliminating the need to hire additional temporary staff to support these tasks.
- Savings by not having the administrative cost of procuring and managing multiple contracts.



Background

- In 2005 the Board approved the award of two "On-Call" engineering contracts.
 - General Architectural and Engineering Services Parsons Transportation Group, Parsons Brinckerhoff Quade and Douglas, and Delon Hampton and Associates (P2D).
 - Planning, Architectural and Engineering Services for future "New Starts" projects – DMJM Harris, Inc.
- Funds to be committed when tasks are issued, subject to budget authorization and availability of funds.
