NARRATIVE

DISCUSSION:

This contract provides for the continuation of services from the Corel Corporation for providing site license software and maintenance for use throughout the Authority.

WMATA has been using Corel Office Suite as it standard word processing and spreadsheet data tool.

This software is obtained through an annual Site License and Maintenance Agreement which also provides technical support and access to software upgrades. These services are available through the GSA IT Schedule and the rates are based on the usage volume of an organization. Where available WMATA piggy backs on existing Federal, State, and Local Government contracts to get the lowest pricing available.

IMPACT ON FUNDING:

For the base year and the three option periods, the total estimated cost of this procurement is \$930,000. This amount is based upon estimated requirements and availability and approval of annual funding as follows:

RECOMMENDATION:

Request that the Board of Directors approve the initiation and award of GSA contract with a not to exceed value of \$145,000 during the base year. This action also requests approval to exercise the three one-year options with not to exceed values in FY2008 through FY2010 of \$200,000, \$260,000, and \$325,000 respectively, subject to Board approval of the fiscal year budgets and availability of funds.
