### **NARRATIVE**

The Office of Track and Structures/Systems Maintenance has the responsibility to inspect and maintain WMATA's bridge structures. In the process of inspecting and maintaining these structures, TRST must occasionally deploy traffic control to divert, slow down and modify traffic movement on the surface roads that WMATA's structures cross over in order for a protected work zone to be established. Traffic controls are a necessary part of highway work zones to warn motorists of hazards, advise them of proper pathways through the zone, delineate areas where they may not operate, and to separate them from workers. This is accomplished by the deployment of a system of traffic control devices.

This procurement will provide the services of a qualified and certified traffic control contractor who will execute the placement of various types of traffic controls in a variety of WMATA locations in the District of Columbia, Maryland and Virginia. The placement of these devices is regulated by the Federal Department of Transportation.

### **ALTERNATIVES:**

There is no practical alternative for this service due to the safety sensitive nature of this work and expertise required to set up a certified traffic control area. Additionally, WMATA does not have the equipment necessary to perform this work.
