SUBJECT:	Procurement of Cross Ties		
PURPOSE:	This action is to obtain authority to initiate and award the competitive procurement of a contract to procure cross ties, to include a three (3) year base period for 10,000 ties in FY 2007, and 5,000 each in FY2008 and FY2009, with options for 5,000 additional ties in FY 2008 and FY 2009. The total quantity of this contract if all options are exercised is 30,000 cross ties.

NARRATIVE

DISCUSSION:

The replacement of cross ties is an annual program maintenance requirement in the Office of Track and Structures Systems Maintenance (TSSM).

There are in excess of 250,000 ties located on the ballasted track sections of the WMATA revenue system and in maintenance yards. Ties are replaced when they become defective and no longer support and distribute the vertical loads of train weight, or maintain correct rail gage and alignment.

Cross ties procured in the requested quantities will provide sufficient amounts to replace projected defective ties. This is a competitive procurement and it is reasonable to expect several offerors.

ALTERNATIVES:

There are no acceptable alternatives. Failure to replace defective ties in a timely manner will jeopardize the integrity of the WMATA system, and adversely impact revenue operations.
