#### NARRATIVE

Contract No. FM8204 was awarded to Union Switch and Signal (US&S) for the design, removal and replacement of existing ATP track circuits. This award included total system responsibility, i.e, manufacturing, testing, delivery, installation, and field testing of new ATP track circuits at Cheverly, Landover and New Carrollton WMATA Metro Rail Stations.

On September 29, 2004, a letter was issued to US&S advising that for safety purposes, WMATA would henceforth use in-house forces for the wayside installation of the track circuits. Installation would still be performed in the Train Control Rooms by US&S. All equipment for wayside installation would be delivered to WMATA including minibonds, rail clamps, bond leads, pigtail and connectors, junction boxes, four and two foot loops, hose loops and other installation hardware for WMATA's use. A credit proposal was received from US&S. The proposal was audited and has been negotiated with US&S for a bilateral agreement of (credit) \$379,393.00.
