Southeastern Bus Garage: Approval to Re-assign Buses

Washington Metropolitan Area Transportation Authority Board Action/Information Summary

DESCRIPTION

There has been a long-standing need to replace the 70-year old Southeastern Bus Garage with a new, modern facility. Staff continues its development of the replacement of the Southeastern Bus Garage with a Metro police training facility on a 16-acre parcel at the former D.C. Village. Staff will recommend several actions for Board approval in December 2007. WMATA is expediting the replacement in order to support the redevelopment of the Anacostia waterfront and to avoid the impact of ballpark events upon bus access at the existing Garage.

Until the replacement facility opens in December 2010, staff has considered a temporary re-assignment of the buses from the Southeastern Garage to other garages for the above reasons. Moreover, to remain at Southeastern Garage would increase annual operations and maintenance costs by \$1.7 million. The estimate to re-assign buses to other garages is \$4.2 million annually. However, the net increase would be \$3.2 million (4.2 less 1.0 cost due to satellite bus parking).

A secondary approach is to relocate the buses to a temporary facility, for which a public hearing is necessary. The basis of the hearing is an alternatives analysis, which also considers the re-assignment of buses. The Alternatives Analysis documentation is available for review by Board members in the Office of Secretary, second floor of the Jackson Graham Building.

FUNDING IMPACT

- For the re-assignment of buses to other garages, the additional annual operating cost due to deadheading would be \$3.2 million. Staff would request approval of an operating budget amendment in December 2007.
- There would be no funding impact for the secondary approach approval to hold a hearing on the alternatives analysis for a temporary facility.

RECOMMENDATION

- That the Board approve the re-assignment of the Southeastern Division buses to other garages.
- [If the Board does not act on the above, then]
 That the Board approve staff to hold a Compact public hearing on the alternatives analysis for a temporary bus facility.



Background

 The existing 106 buses at SE Garage would be re-assigned to six other garages per the table below.

Total	106




Option of Temporary Bus Facility

 Should the Board not select the re-assignment of buses to other garages, there is an option to relocate the buses to a temporary facility, for which a public hearing is necessary. The basis of the hearing is an alternatives analysis, which also considers the re-assignment.

W Street, NE (with first year at SE Garage)	8.8	5.6	8.7	23.1
Howard Road, SE (with first year at SE Garage)	16.4	2.1	12.3	30.8
Re-assignment (at annual cost of 3.2)	0.0	9.1	0.4	9.5



Next Steps

Through Fall 2007:

- Sale process of SE Bus Garage.
- Advertisement & permits for site preparation contract.
- Design of the permanent bus facility.
- Approval of public hearing process, if required, for temporary bus facility.

December 2007 Board Actions:

- Approval of project and amendment of Mass Transit Plan.
- Selection of temporary bus facility, if any, for early relocation.
- Sale of Southeastern Bus Garage.
- Conveyance of District D.C. Village property.
- Amendment of capital budget for construction contracts.
- Amendment of operating budget for re-assignment of buses.
- Award of site preparation contract.
- Authority to advertise permanent bus facility contract.

RESOLVED, That the Board of Directors authorizes the General Manager to release the Public Hearing Staff Report (Staff Report) for public comment, as soon as the Staff Report is available, subject to later submission of the Staff Report Supplement, with final staff recommendations, to the Board of Directors for its approval. All Board members will receive the Staff Report concurrently with its release for public review; and be it finally
