#### TITLE:

2017 Inauguration Service, Fares and Security

#### PRESENTATION SUMMARY:

Brief the Board on plans to accommodate travel on Inauguration Day, January 20, 2017, and seek Board approval of Inauguration Day special service, fares and security items.

#### **PURPOSE:**

Seek Board approval for:

- One-hour early Metrorail opening; peak fares from 4 a.m. to 9 p.m.
- Regular "rider" rate charged at all Metro parking facilities
- Commemorative SmarTrip® with special pass product, sold in advance for \$10
- Option to "hand-sell" remaining commemorative cards on Inauguration Day for \$14.50
- Waiver of \$2 new card fee for one-day rail passes sold via "hand sales" on Inauguration Day
- Recognition of external law enforcement volunteers as agents of WMATA

#### **DESCRIPTION:**

Staff has developed service, fare and security plans to accommodate the high volume of travel on Inauguration Day, ease overcrowding to the extent possible, speed access into the system through parking lots and rail stations, and improve customer convenience with simplified ticketing.

### **Key Highlights:**

It is important that the Board take action now so that event planners and attendees can be advised of Metro's service, fare and security plans for Inauguration Day.

### **Background and History:**

On January 20, 2009, Barack Obama was sworn in as the 44<sup>th</sup> President of the United States. Due to the historic nature of the election of the first African-American President, the events drew remarkably large crowds, culminating with an estimated 1.8 million people gathering on the National Mall and along the Inaugural parade route – the largest event in the history of the District of Columbia. In 2009, Metro safely moved 1.5 million customers on Inauguration Day, including 1.1 million on Metrorail.

In 2013, the Presidential Inauguration and Inaugural Parade took place on Monday, January 21 – the Martin Luther King, Jr holiday. Metrorail carried more than 730,000 riders that day.

Metro operated under the following service and fare plans in 2013:

- Extended rail system operating hours from 4 a.m. 2 a.m.
- Peak service/fares until 9 p.m.
- Provided weekday bus service levels
- Normal parking fees charged on a federal holiday
- Commemorative fare cards sold with one-day rail pass and bus flash pass (\$14 for paper; \$15 for SmarTrip®)

Metro staff estimates that we spent approximately \$2 million to \$2.4 million supporting the 2013 Inauguration. This included extra bus and rail operations, marketing and signage, additional customer service staff, and additional security expense (MTPD, as well as outside police brought in for additional support). We were reimbursed approximately \$700,000 for security costs through the Department of Homeland Security/Federal Emergency Management Agency (DHS/FEMA). No reimbursement for other costs.

#### Discussion:

This coming year, the public swearing in of the President and the Inaugural Parade will take place on Friday, January 20, 2017.

Led by representatives from the Metro Transit Police Department and the Office of External Relations, WMATA is participating on Presidential Inaugural Committees (PICs) convened by the local jurisdictions and the U.S. Secret Service.

The U.S. Secret Service PIC involves many agencies, including the Federal Bureau of Investigation (FBI), Federal Emergency Management Agency (FEMA), U.S. Department of Homeland Security (DHS), D.C. Homeland Security and Emergency Management Agency (HSEMA), D.C. Fire and EMS, Metropolitan Police Department, U.S. Coast Guard, Joint Force Headquarters- National Capitol Region, U.S. Park Police, U.S. Capitol Police, D.C. National Guard, U.S. Attorney's Office, U.S. Department of Defense, National Parks Service (NPS) and Joint Congressional Committee on Inaugural Ceremonies (JCCIC).

WMATA representatives are on the following PIC Subcommittees: Crowd Management, Fire Life Safety, Public Affairs, Transportation, and Intelligence and Counter Terrorism.

In addition, WMATA has organized an internal PIC, with representatives from the following Offices: Safety, Metro Transit Police Department, Rail Transportation, Bus Transportation, Bus Planning, MetroAccess, Management and Budget Services, Treasury, Fare Collection, AFC Maintenance, AFC Engineering, Elevator/Escalator, Parking, Long Range Planning, Media Relations, External Relations, Bus Maintenance, Plant Maintenance, Automatic Train Control Maintenance, Car Maintenance, Communications, Traction Power, and Track/Structures.

To develop WMATA's 2017 Inauguration Plan, staff reviewed previous Inauguration service, fare and security plans, considered recent experiences and lessons learned, and continue to coordinate with local jurisdictions and event planners.

While many details about Inauguration Week activities, including the Swearing-In and Inaugural Parade, will not be decided until after the Presidential Election on November 8, 2016, it is important that Metro take action now to finalize our service and fare plans and provide advance notice to organizers.

Therefore, staff proposes the following for the 2017 Inauguration:

- Open Metrorail one hour early, at 4 a.m., and close the system at midnight.
- Operate peak Metrorail service level from 4 a.m. to 9 p.m., with peak fares charged from opening until 9 p.m.
- Suspend SafeTrack maintenance work during Inauguration Week, January 14-22.
- Operate regular weekday Metrobus service levels, except for certain downtown zones that may be closed to traffic. Regular bus fares collected.

On Inauguration Day, staff proposes charging the "rider" parking rate at all lots. Currently, a higher, "nonrider" parking fee is charged at New Carrollton, Twinbrook and White Flint stations for customers using credit cards or departing more than two hours after exiting the Metro system. The one-day adjustment would help to accommodate the large number of visitors expected on Inauguration Day, many of whom may not have considered parking when they loaded money on their SmarTrip® cards.

Staff also proposes selling a special commemorative SmarTrip® card, via online or bulk order advanced purchase, for a price of \$10. The commemorative card would be preloaded with a special one-day pass for unlimited travel on Metrorail and Metrobus, good only on January 20, 2017. The commemorative card will function as a traditional SmarTrip® card and can be loaded with additional fare value or pass products for use either before or after the Inauguration.

If additional stock remains on Inauguration Day, staff will have the option to hand-sell the commemorative cards, loaded with the special Inauguration Day rail and bus pass, on the day of the Inauguration at a cost of \$14.50.

Finally, staff recommends waiving the \$2 "new card" fee on Inauguration Day for hand sales of our \$14.50 one-day rail pass. This would make the hand-sale option price competitive with vending machines at end-of-line stations, allowing us to **further** reduce lines by distributing crowds between the two options.

#### MTPD Security Measures

The Metro Transit Police Department (MTPD) is collaborating with law enforcement agencies, led by the United States Secret Service, to devise an overall security strategy for the National Capital Region. Throughout the planning process and Inauguration Day events, the primary mission of the MTPD will continue to be the safety and security of riders, WMATA employees, revenue and facilities.

Because of increased ridership and national security interests, the MTPD has requested

assistance from law enforcement agencies, both regional partners and transportation partners throughout the United States, to assist with security in the Metro system. MTPD will be all-hands-on-deck for the events, and we are requesting in excess of 150 additional sworn police officers to augment our force. In addition, the Transportation Security Administration (TSA) has agreed to provide a contingent of Visible Individual Prevention and Response (VIPR) teams to assist with rail system security. All supplementary officers will undergo a process of credentialing, system safety training, and swearing-in by the United States Marshals Service.

MTPD requests that the Board recognize these volunteers from the external law enforcement agencies as agents of WMATA under Section 80 of the WMATA Compact and that the Indemnification Policy, as amended, shall apply to these volunteers.

MTPD applied for, and was awarded a Department of Homeland Security (DHS) grant of just over \$250,000 specifically for the Inauguration. It is anticipated that the majority of the funds will be utilized for more than 300 hours of overtime. Neither grant funding, nor WMATA operational funds will be available to cover travel expenses for visiting officers.

Over the next several weeks, more detailed plans will be identified and communicated to our riders and employees regarding event security measures. Some tactics, such as the creation of a hardened security perimeter surrounding the U.S. Capitol, the Lincoln Memorial, the White House, and the Inaugural Parade Route, will necessitate the closing of rail stations within the perimeter for certain events. The MTPD will work hand-in-hand with all WMATA business partners to ensure that both operational and security objectives are addressed for the event.

#### **FUNDING IMPACT:**

The funding impact will be determined after Inauguration Day, based on ridership and reimbursements from the event organizers. So far, MTPD has received a \$250,000 grant from Department of Homeland Security (DHS).

In reviewing previous Inauguration Day costs, Metro staff estimates that we spent approximately \$2 million to \$2.4 million supporting the 2013 Inauguration. We were reimbursed approximately \$700,000 for security costs through the DHS/Federal Emergency Management Agency (DHS/FEMA). No reimbursement were received for other costs.

# RESOLUTION OF THE BOARD OF DIRECTORS OF THE WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY

WHEREAS, The public swearing-in of the new President and the Inaugural Parade will take place on Friday, January 20, 2017; and

WHEREAS, While many details concerning inauguration week activities will not be decided until after the election, it is important that Metro act now to finalize its service and fare plans and provide advance notice to inauguration organizers and attendees; and

WHEREAS, Metro staff have reviewed previous inauguration service and fare plans, considered recent experiences and lessons learned, and coordinated with local jurisdictions and event planners; and

WHEREAS, The General Manager/Chief Executive Officer (GM/CEO) has determined that SafeTrack maintenance and rebuilding efforts will be suspended during inauguration week (January 14-22, 2017), in order to minimize impacts on visitors and inauguration attendees; and

WHEREAS, Metro staff will be present on the morning of Inauguration Day at key Metrorail stations that are expected to have a high volume of customers and will offer "hand sales" of certain fare products in order to supplement the existing fare vending machines and help move passengers through the stations; and

WHEREAS, In Resolution 2012-28, the Board of Directors adopted a section in the Washington Metropolitan Area Transit Authority (WMATA) Tariff to address fares and service levels on Inauguration Day; and

WHEREAS, Staff recommends additional changes that require Board of Directors approval in order to accommodate the high volume of travel on Inauguration Day 2017, ease overcrowding, speed access into the system through parking lots and rail stations, and improve customer convenience; now, therefore be it

*RESOLVED,* That Metrorail shall open one hour early on January 20, 2017, beginning service at 4:00 a.m.; and be it further

*RESOLVED*, That the GM/CEO shall determine if additional changes to Metrorail service are necessary in order to accommodate expected crowds at inauguration week activities, and shall implement such service changes as required; and be it further

*RESOLVED*, That Metro shall waive the higher "non-rider" parking fee currently charged at New Carrollton, Twinbrook and White Flint stations to customers using credit cards or departing more than two hours after exiting the Metro system; and be it further

RESOLVED, That Metro shall offer customers, via online or bulk order advanced purchase, a commemorative Inauguration 2017 SmarTrip® card pre-loaded with a special one-day pass for unlimited travel on Metrorail and Metrobus good only on January 20, 2017, and that the total price for this special commemorative card and pass shall be sold at a discounted price of \$10.00, inclusive of the normal \$2.00 fee for a new SmarTrip®; and be it further

*RESOLVED*, That on Inauguration Day only, Metro shall waive the normal \$2.00 fee associated with purchasing a new SmarTrip® card for all one-day unlimited rail only passes purchased directly from Metro staff via "hand sales" in the Metrorail stations; and be it further

*RESOLVED*, That staff shall have the option of hand-selling the commemorative cards on the day of the inauguration at a cost of \$14.50 which shall be loaded with the special Inauguration Day rail and bus pass which shall be good only on January 20, 2017; and be it finally

*RESOLVED,* That this Resolution shall be effective 30 days after adoption in accordance with § 8(b) of the WMATA Compact.

# RESOLUTION OF THE BOARD OF DIRECTORS OF THE WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY

WHEREAS, Every four years, the Inauguration of the President of the United States occurs in the District of Columbia, which results in a large influx of visitors to the District of Columbia; and

WHEREAS, The Washington Metropolitan Area Transit Authority (WMATA) experiences an extraordinary increase in ridership throughout the Metro transit system during inaugural events; and

WHEREAS, The Metro Transit Police Department (MTPD) provides security, emergency management, crowd control and support of Metro operations throughout the transit system during these inaugural activities; and

WHEREAS, MTPD has requested volunteer aid and assistance from external law enforcement agencies for the 2017 Inauguration Day; and

WHEREAS, MTPD will need aid and assistance from external law enforcement agencies during future inaugural events; now, therefore be it

RESOLVED, That the General Manager/Chief Executive Officer (GM/CEO), or designee, is authorized to accept volunteers from external law enforcement agencies to aid MTPD during the 2017 inaugural events in matters of security and crowd control; and be it further

*RESOLVED*, That the GM/CEO, or designee, is authorized to accept volunteers from external law enforcement agencies to aid MTPD during future inaugural events in matters of security and crowd control, with notice given to the Board of Directors in advance of the volunteers' activities; and be it further

*RESOLVED*, That the volunteer participants from the external law enforcement agencies for the 2017 inaugural events, as well as any and all volunteers from external law enforcement agencies for any future inaugural events, will be considered agents of WMATA within the meaning of Section 80 of the WMATA Compact; and be it further

*RESOLVED*, That the provisions of the Indemnification Policy, as amended, shall apply to any and all volunteers from external law enforcement agencies for the 2017 inaugural events as well as to any and all such volunteers for any future inaugural events; and be it finally

*RESOLVED,* That this Resolution shall be effective 30 days after adoption in accordance with § 8(b) of the WMATA Compact.
