TITLE:

Indemnification - City of College Park

PRESENTATION SUMMARY:

Request Board approval to indemnify the City of College Park in order to use their facilities to hold a public hearing.

PURPOSE:

Request Board approval to indemnify the City of College Park within a facility usage agreement.

DESCRIPTION:

WMATA will be holding hybrid public hearings on its Proposed FY2023 Operating and Capital Budgets and FY2023-2028 Capital Improvement Program, which will allow for both virtual and in-person participation. A total of three hearings will be held, one each in the District of Columbia, Maryland and Virginia in order to allow for convenient in-person participation.

The City of College Park, Maryland, has agreed to host the Maryland WMATA Compact Public Hearing on Metro's Proposed FY2023 Operating and Capital Budgets and FY2023-2028 Capital Improvement Program at its new city hall facility. The agreement between Metro and the City of College Park for use of their city hall facility contains indemnification language.

Under Resolution 2011-30, Board of Directors' approval is required to indemnify a counterparty.

The City of College Park, Maryland is an interested party.

Key Highlights:

- WMATA seeks to use City of College Park facilities for one of its Compact Public Hearings on its Proposed FY2023 Operating and Capital Budget and FY2023 Capital Improvement Program.
- The agreement to use the City of College Park facility contains language

indemnifying the City. The City has indicated it cannot waive that language in its agreement with Metro.

- In order to maintain the schedule of public outreach for the Proposed FY2023 Budget, Metro needs to use the City of College Park's facilities. This requires signing their usage agreement and agreeing to indemnify the City.

Background and History:

Metro conducts public outreach, including Compact public hearings, annually to get feedback on its proposed budgets, Capital Improvement Program and any proposed changes to service and fares included in those budgets. Through the hearings on the Proposed FY2021 Budget (February 2020), Metro conducted in-person public hearings. For the Proposed FY2022 Budget (February 2021), Metro conducted its hearings virtually, in order to adhere to public health guidelines associated with the COVID-19 pandemic. In order to conduct its hearings virtually, Metro had to obtain a waiver from the Commonwealth of Virginia, which requires Metro to hold a public hearing on its capital improvement program "within the geographic limits of the Northern Virginia Transportation Commission."

For hearings on the Proposed FY2023 Budget, Metro was unable to obtain a waiver from the Commonwealth of Virginia to hold a virtual public hearing. In order to ensure equitable access to the public hearing process for all customers within Metro's service area, the Board decided to hold three "hybrid" Compact public hearings that would allow for both virtual and in-person participation, one in each of Metro's three Compact jurisdictions. Staff selected the College Park City Hall as its Maryland location due to its location, proximity to transit and facilities - both physical and techological to allow for hybrid meetings and for social distancing.

Discussion:

In order to use the College Park City Hall for one of its Compact public hearings, Metro must agree to the indemnification language contained in the facility usage agreement. Under Resolution 2011-30, the Board has exclusive authority to indemify counterparties.

Failure to sign an agreement with the City of College Park for use of its facility would require Metro to find a new location for a Compact public hearing within Maryland, delaying the public outreach timeline for the Proposed FY2023 Budget and ultimately delaying its adoption by the Board.

FUNDING IMPACT:

No impact on funding. This action will only allow Metro and the City of College Park to enter into an agreement to use the City's facility, which is being provided free of

charge.
