10. <u>Approval of an Easement to the District of Columbia for the Metropolitan Branch Trail</u>

Approval to grant an easement to the District of Columbia to install and maintain an infiltration trench and pipe across a portion of Metro property near the New York Ave-Florida Ave-Gallaudet U Metrorail station to facilitate drainage for the adjacent Metropolitan Branch Trail.

# 11. Approval of Tax Advantaged Lease Rail Car Substitution

Approval of two resolutions to execute documents, certificates, and assurances necessary to effectuate the substitution of Metro Rail Car Numbers 1000, 1001, 3068 and 3069 for Rail Car Numbers 1130, 1131, 3036 and 3037.
