PURPOSE/KEY HIGHLIGHTS	<p>Staff requests Board approval to waive all parking fees – both rider and non-rider – at five Metrorail stations during the summer 2025 Major Construction - Blue Line and Green Line project.</p> <p>Waiving parking fees acknowledges the inconvenience caused by necessary maintenance and aligns with Metro’s Strategic Transformation Plan’s goal of service excellence by reducing barriers to mobility during major service disruptions</p> <p>Customers who normally park at the stations can continue their trips using shuttle service</p>		
DISCUSSION	Metro will temporarily close select Blue and Green line stations in July and August 2025 to advance capital work focused on safety

	<p>improvements and station modernization.</p> <p>To support impacted customers, staff recommends waiving parking fees during each shutdown period. Bus shuttle service will be provided at the affected stations.</p> <p>Blue Line Franconia-Springfield and Van Dorn St stations: Closed July 5–July 26, 2025</p> <p>Green Line Branch Ave, Suitland, and Naylor Rd stations: Closed August 2–August 31, 2025</p>
<b>INTERESTED PARTIES</b>	No interested parties identified.
<b>RECOMMENDATION/NEXT STEPS</b>	Board approval to waive parking fees at Franconia Springfield, Van Dorn St, Branch Ave., Suitland and Naylor Rd. stations.
<b>FUNDING IMPACT</b>	<p>The estimated parking revenue loss across all five stations is \$341,730. This amount will be fully reimbursed through the Summer 2025 Major Construction – Blue Line and Green Line project – with no impact on the operating subsidy for contributing jurisdictions.</p> <p>Please see attached memo for details.</p>

WHEREAS, Pursuant to Compact Section 60, the Board of Directors has sole and exclusive jurisdiction over the rates and fares to be charged for service performed by transit facilities owned or controlled by WMATA; and

WHEREAS, Five stations along the Blue Line and Green Line will be closed due to constructing safety and other improvements along those lines beginning on or about July 5, 2025; and

WHEREAS, Staff recommends temporarily waiving all rider and non-rider parking fees at the Franconia Springfield, Van Dorn Street, Branch Ave, Suitland, and Naylor Road station parking facilities during the Blue Line and Green Line improvement projects;

NOW, THEREFORE, be it

*RESOLVED*, The Board of Directors waives collection of all rider and non-rider parking fees at the Franconia Springfield, Van Dorn Street, Branch Ave, Suitland, and Naylor Road station parking facilities during the Blue Line and Green Line improvement projects for a period not to exceed six months from implementation of the waiver at the relevant stations and authorizes the General Manager and Chief Executive Officer to terminate the waiver sooner; and be it finally

*RESOLVED*, That to allow for the timely implementation of the parking fee waiver this Resolution shall be effective immediately.
