Art in Transit Program Delegation

PRESENTATION SUMMARY:

Approve delegation of authority to General manager/CEO regarding Art in Transit projects

PURPOSE:

The purpose of this item is to ask WMATA's Board of Directors to delegate review and approval of Art in Transit projects to the General Manager/Chief Executive Officer, or designee.

DESCRIPTION:

The GM/CEO is responsible for all Metro activities, subject to the Board of Directors' policy direction. Resolutions #99-70 and #00-62 established the Board's expanded role in the art selection process for art to be placed in the transit system via the Art in Transit Program (AIT). In order to increase Metro's ability to successfully implement AIT projects and initiatives in a cost-effective and timely, responsive manner, the Board is being asked to delegate to the GM/CEO the authority to review and approve AIT projects and initiatives, and to make any changes necessary to policy or guidance to achieve that end. To keep the Board informed and to allow time for any concerns to be communicated, AIT will provide a quarterly update of arts in progress and provide advance notification along with images of artworks that the General Manager is considering for approval.

Key Highlights:

AIT oversees all visual and performing arts projects and initiatives throughout the Authority's system. Delegation of review and approval of AIT projects and initiatives to the GM/CEO will streamline the current AIT review and approval process thereby increasing the program's ability to respond to requests for collaborations and artwork offers.

Background and History:

In 1975, the Board of Directors adopted Resolution #75-24 approving the installation of artwork in the Metrorail system. Along with establishing the

Board expanded role in the art selection process, Resolutions #99-70 and #2000-62 further recognized that art in the transit system promotes better customer service and increased ridership through passenger satisfaction with the visual environment. For 30 years, AIT has worked with businesses, government agencies, professional organizations and community groups to incorporate artworks and provide performances to enhance Metro's public spaces and provide high-quality arts experiences for transit customers and the public.

Discussion:

As part of the Authority's current efforts to strengthen customer confidence and provide better service, AIT is currently actively working with local agencies, art institutions, and communities to add several artworks to the Metrorail system. The proposed program changes will benefit customers and Metro by improving the Authority's ability to process requests for collaboration and increase prospects of securing external sponsorship of various projects. As a result, the proposed changes also have the potential to increase the program's visibility and improve customers' experience.

RESOLVED, That this Resolution shall be effective 30 days after adoption in accordance with § 8(b) of the WMATA Compact.
