WHEREAS, Pursuant to Resolution 2006-18, the Board of Directors established the Office of Inspector General to conduct and supervise audits, program evaluations and investigations relating to Authority activities; promote economy, efficiency and effectiveness in Authority activities; and keep the Board of Directors fully and currently informed of deficiencies in Authority activities, as well as the necessity for, and progress of, corrective action; and

WHEREAS, Resolution 2006-18 provides that the Inspector General shall have a five-year term with reappointment of no more than two additional terms; and

WHEREAS, In order to streamline the reappointment process, the Board desires to amend the Inspector General's term to three years, with automatic extensions for successive one-year terms unless within 60 days of the end of any term the Board notifies the Inspector General that his/her term will not be extended, unless terminated sooner; and

WHEREAS, The Inspector General is an Officer of the Authority, who reports to the Board of Directors and leads the Office of Inspector General; and

WHEREAS, In Resolution 2022-05, the Board appointed Rene Febles as Acting Inspector General effective April 17, 2022, until a permanent Inspector General is appointed; and

WHEREAS, The Board wishes to appoint Mr. Febles as Inspector General;

NOW, THEREFORE, be it

RESOLVED, That the Board of Directors deletes in its entirety the seventh *RESOLVED* clause in Resolution 2006-18; and

RESOLVED, That the Inspector General shall serve a term of three years, with automatic extensions for successive one-year terms unless within 60 days of the end of any term the Board notifies the Inspector General that his/her term will not be extended, unless terminated sooner; and
