PRESENTATION SUMMARY:

Your Metro, The Way Forward was developed to guide Metro's strategy and actions over the next five + years to meet the evolving needs of its customers and employees. The plan will guide both long-term strategy and day-to-day decision making as Metro continues to regain ridership post-pandemic and respond to changing mobility patterns.

This presentation is to request authorization from the Board to hold a public hearing on the draft Strategic Transformation Plan.

PURPOSE:

To request authorization from the Board of Directors to hold a public hearing on the draft Strategic Transformation Plan for regional input and comment.

DESCRIPTION:

Your Metro, the Way Forward was developed to guide Metro's strategy and actions over the next five + years as Metro works to meet the evolving needs of its customers and employees. The plan will guide both long-term strategy and day-to-day decision making as Metro continues to regain ridership post-pandemic and respond to changing mobility patterns to ensure the agency captures the needs of the community.

Key Highlights:

- The strategic plan defines Metro's priorities and connects the mission, vision, and goals with actionable initiatives that will drive progress.
- Metrics and targets have been identified and laid out to measure progress against the plan. This will enhance transparency and build trust with Metro's customers and stakeholders.
- The plan was developed by the Board of Directors and management through direct and active input from Metro's customers, staff, and stakeholders.

- Metro will seek input from the community by holding a hybrid public hearing to collect feedback on the draft plan.
- The feedback received will be incorporated into the final plan and then presented to the Board of Directors for recommendation of adoption in winter 2023.

Background and History:

Metro began the process for the the Strategic Transformation Planning effort in August 2023 alongside the Board of Directors. Since then, the plan has been developed by direct input and shared updates with the Board of Directors during their Board Executive Committee meeting on December 8, 2022.

Discussion:

Metro regularly updates their Strategic Plan, typically every 3.5 years. Holding a public hearing in Virginia is a requirement as part of the dedicated funding legislation, and an industry best practice for the organization.

Your Metro, The Way Forward was developed by the Board of Directors and management with direct input from customers, stakeholders, and staff. The public hearing is the next phase of community engagement to garner feedback on the draft plan. Feedback will be incorporated into a final plan which will then be presented to the Board of Directors for recommendation of adoption in winter 2023.

Cl. 8); and be it further

RESOLVED, That the Board of Directors directs the General Manager and Chief Executive Officer or his designee to report on the findings of the public hearing on the proposed Strategic Transformation Plan: Your Metro, The Way Forward; and be it finally

RESOLVED, That in order for the Board of Directors to incorporate public input in its deliberations on the Strategic Transformation Plan: Your Metro, The Way Forward, this Resolution shall be effective immediately.
