# **Approval of Name Change for White Flint Metrorall Station**

#### TITLE:

Metrorail Station Name Change Proposal

#### PRESENTATION SUMMARY:

Jurisdiction request for Metrorail station name change.

#### **PURPOSE:**

Board consideration of a new name proposal for the White Flint Metrorail station.

#### **DESCRIPTION:**

There are no interested parties in this matter.

#### **Key Highlights:**

- Silver Line Phase 2 service presents an opportunity to review current station names during station signage and map updates.
- A proposal was received from Montgomery County to change the name of White Flint Metrorail station, along with letters of support from various community groups. Letters of support can be provide.
- The jurisdiction has committed to fund \$332K for the signage changes.
- The proposed name is in response to efforts to rebrand the area around the Metrorail Stations to encourage transit-oriented development.
- WMATA conducted a survey of riders and the public to collect feedback about the proposed station name.
- The Montgomery County survey yielded 4,720 responses. The survey found that the majority prefer the current station name.

#### **Background and History:**

Station names are guided by Board policy (P/I 4.1/4). Station name changes (or new names) are to be submitted by jurisdictions to the Metro Board for approval. The submissions must include community support and a funding commitment for any signage and map changes.

Major tenets of the Metro System Station Names Policy include the following:

- Jurisdictions must complete outreach in their communities to determine potential station names.
   Names are then formally submitted to WMATA staff to conduct required regional research on the potential names;
- Names should identify the station locations by geographical features or centers of activity when landmarks are within one half mile of the station (walking distance);
- Names should be distinctive and evoke imagery in the mind of the patron; and

• Each station name should be no longer than 19 characters (including spaces and punctuation), except for transfer station names, which should not exceed 13 characters.

In May 2011, the Board revised the Metro System Station Names Policy to include the following:

#### **Higher Education/Universities:**

- Grandfather all existing higher education/universities
- Limit future names to main campuses within ½ mile

#### Institutions/Landmarks:

- Retain current policy
- · Grandfather all existing institutions/landmarks
- Encourage landmarks on neighborhood and interactive maps

#### Hospitals:

· Retain current practices

#### Commercial Naming Rights:

- Continue current practice of not selling commercial naming rights
- Promote station domination and other opportunities to grow revenue outside of changing station names

#### Discussion:

In advance of the next phase of Silver Line service, Metro is preparing for systemwide signage and rail map changes. Notices went to the Board and jurisdictions that station name changes could be considered as part of the signage changeouts. The signage changes need to be finalized by December 31, 2021, in order to meet all deadlines and avoid delay penalties.

Montgomery County submitted a proposal under the current policy to change the name of White Flint Metrorail Station to North Bethesda Metrorail Station. The jurisdiction has committed to fund \$332K needed to make signage changes throughout the Metrorail system.

The proposed name change is in response to economic redevelopment efforts by the jurisdiction.

White Flint Metrorail System opened in 1984, serving those closest to the Rockville and Bethesda neighborhoods. It was named based on the station's close proximity to White Flint Mall. Since approximately 2010, the community began to evolve, and many believe that the name North Bethesda best represents this area. White Flint Mall was destroyed in 2017.

Following community outreach, Montgomery County submitted the following name change to WMATA for customer testing:

· North Bethesda

Consistent with the policy, WMATA conducted an online survey. The survey was actively promoted via local TV news, print media and social media. 4,720 respondents completed the survey..

Respondents were asked to rate the potential station name in meeting each of the following Metro System Station Names Policy criteria:

- · Brevity: Easy to remember
- Uniqueness: Not easily confused with other station names
- Evocation: Appealing; Clearly conveys where you are when you reach the station

• Relevance: Describes the location well

The results of the survey found that the current station name of "White Flint" is significantly preferred over "North Bethesda" across all key criteria.

#### **RECOMMENDATION:**

Our history with Metrorail Station naming informs us that our riders and the communities we serve develop strong attachments to rail station landmarks and resist change. It speaks to the strength that WMATA has to help support jurisdictions leverage the power of Metrorail station names to create a sense of place, encourage transit-oriented development, and rebrand an area while riders learn about new destinations, landmarks, and changing travel patterns.

In the case of "North Bethesda" 51% of the survey respondents found the name easy to recall and not confusing with other names. However, the naming convention itself, North Bethesda was not an obvious choice with respondents because it is not currently connected to a sense of place. That said, noteworthy developments such as Pike & Rose have started to adapt the namesake into their branding and identify as being located in the city of North Bethesda. We will continue to see this take hold throughout the county. Should the Board wish to approve the jurisdiction's request, it is likely that the new name will become synonymous with the surrounding community over time and customers will find it sufficient for wayfinding.


# Metro System Station Names Policy

- Landmarks are within walking distance
- Jurisdictions

  - Submit names
  - Provide funding commitment

### Staff Recommends Approving Name Change

### White Flint Metro Station

- There is a lot of support for changing the White Flint station name, but North Bethesda is not an obvious choice because it is not currently connected to a sense of place
- Developers have begun integrating North Bethesda in branding, collateral and signage
- Recommend moving forward with North Bethesda as station name since the county has plans for name to become synonymous with surrounding area over time

# RESOLUTION OF THE BOARD OF DIRECTORS OF THE WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY

WHEREAS, Pursuant to Resolution 2011-36 and Metro System Station Names Policy  $(P/I \ 4.1/4)$ , as amended, the Board of Directors is required to approve all changes to Metro station names; and

WHEREAS, Montgomery County has requested that White Flint Station be changed to North Bethesda Station and committed the funding (\$332,000) for the full cost of the name change; and

WHEREAS, The station name change will continue to assist the traveling public in wayfinding;

NOW, THEREFORE, be it

*RESOLVED,* That the Board of Directors approves the following station name change:

White Flint Station to North Bethesda Station

that will take effect upon installation of new signage associated with the beginning of passenger service for Silver Line Phase Two stations; and be it finally

*RESOLVED,* That this Resolution shall be effective 30 days after adoption in accordance with Compact Section 8(b).
