### TITLE:

Accessibility Advisory Committee Appointments

### PRESENTATION SUMMARY:

The terms of seven members of the Accessibility Advisory Committee (AAC) representing the three jurisdictions have expired. In addition, there is one vacancy in the District of Columbia, a vacancy in the Commonwealth of Virginia, and one Access For All vacancy.

The attached resolution seeks board reappointment of seven members currently serving beyond the expiration of their terms, and the appointment of three members.

### PURPOSE:

Board approval of three vacancies on the Accessibility Advisory Committee (AAC), and Board approval of reappointment of seven members currently serving beyond the expiration of their terms.

### DESCRIPTION:

The Department of Access Services (ACCS) with input from current AAC members recommended seven current committee members for reappointment and three new individuals for appointment in the attached resolution in accordance with the AAC bylaws (Resolution 2015-20). The attached resolution lists the names, jurisdictions, and terms for each of the individuals.

#### Key Highlights:

Each of the nominees meets the Board's criteria for membership as established by Resolution 2015-20; and the group represents diversity in age, disability type, and uses of all modes of transportation services.

#### Background and History:

The Board of Directors established an Accessibility Advisory Committee and adopted governing bylaws and standards of conduct on April 23, 2015 under Resolution 2015-20. AAC bylaws require Board to appoint AAC membership.

The AAC is an advisory committee that provides recommendations on accessibility related items to the Board of Directors. The mission of the AAC is

to actively seek input from a broad range of seniors and persons with disabilities and organizations with an expressed interest in public transportation for seniors and persons with disabilities on operational issues that affect the accessibility of Metrorail, Metrobus and MetroAccess services; advise the Board on ways to resolve such issues in order to improve Metrorail, Metrobus, and MetroAccess; promote responsiveness to riders who are seniors or persons with disabilities; and recommend possible solutions to the Board of Directors and staff, based on public input, to effectively address the diverse concerns of seniors and persons with disabilities who use Metro services.

The AAC consists of 18 regular members and two additional members recommended by the Chair of the Metropolitan Washington Council of Government's Access for All Committee. AAC members serve staggered terms, so that approximately one third of the committee is replaced or reappointed each year.

#### **Discussion:**

ACCS confirmed the qualifications of the current committee members of the disability community in order to reappoint seven members on the Accessibility Advisory Committee (AAC) and appoint three individuals to the AAC. ACCS received input from current members of the AAC throughout the process, and now recommends the reappointment of seven existing members and three new members to the AAC.


