TITLE:

Accessibility Advisory Committee Appointments

PRESENTATION SUMMARY:

There are two vacancies on the Accessibility Advisory Committee (AAC) representing two of the jurisdictions.

Staff outreach, recruitment, and selection using Board-approved criteria yielded the two individuals recommended for approval in the attached resolution.

PURPOSE:

Board approval of the appointment of two individuals to the Accessibility Advisory Committee (AAC).

DESCRIPTION:

To recruit members, the staff conducted outreach; interviewed applicants; and selected two individuals to be recommended for appointment in the attached resolution in accordance with the AAC bylaws (Resolution 2011-09). The attached resolution lists the names, jurisdictions, and terms for each of the individuals to be appointed.

Key Highlights:

Each of the nominees meets the Board's criteria for membership as established by Resolution 2011-09; and the group represents diversity in age, disability type, and uses of all modes of transportation services.

Background and History:

The Board of Directors established an Accessibility Advisory Committee and adopted governing bylaws and standards of conduct on September 24, 2009 under Resolution 2011-09.

The AAC is an advisory committee that provides recommendations on accessibility related items to the Board of Directors. The mission of the AAC is to actively seek input from a broad range of seniors and persons with disabilities and organizations with an expressed interest in public

transportation for seniors and persons with disabilities on operational issues that affect the accessibility of Metrorail, Metrobus and MetroAccess services; advise the Board on ways to resolve such issues in order to improve Metrorail, Metrobus, and MetroAccess; promote responsiveness to riders who are seniors or persons with disabilities; and recommend possible solutions to the Board of Directors and staff, based on public input, to effectively address the diverse concerns of seniors and persons with disabilities who use Metro services.

The AAC is comprised of 20 members - six members each from Maryland, Virginia, and the District of Columbia, with two additional members from the Access for All Committee of the Metropolitan Washington Council of Governments. AAC members serve staggered terms, so that approximately one third of the committee is replaced or reappointed each year.

Discussion:

Staff engaged in an effort to identify qualified members of the disability community in order to fill two vacancies on the Accessibility Advisory Committee (AAC). Staff received input from current members of the AAC throughout the replacement process, and now recommends the appointment of two new members to the AAC.
