I. Call to Order/Approval of Agenda

Ms. Kortum called the April 2017 meeting of the Metro Riders' Advisory Council (RAC) to order at 6:30pm. The agenda was approved without objection.

II. Safety Discussion with WMATA Board Members and Staff

To kick off the conversation, Ms. Baker, Chair of the Safety Committee, expressed the Council's interest in learning more about ways they can assist WMATA with advancing safety goals. She also referenced two recent safety and security reports about personal safety and crime, as the basis for questions submitted to staff.

Mr. Corcoran introduced himself and began by covering a timeline of the company's audit history, and gave a brief overview of the Inspector General's (IG) role. The IG also reports to the Audit Committee. A new Inspector General join the team in mid-April. Mr. Corcoran also covered the company's financial position and discussed the challenges ahead. He also stated how important secured funding will be for Metro's sustainability.

Mr. Lauby, introduced himself and started out discussing Metro's safety performance. He stated that changes in management can help propel Metro forward, in addition to strengthening its safety metrics. The organization will have to police its own culture on an on-going basis – no level of oversight can produce better outcomes.

Council members followed up with questions about safety trainings, emergency preparedness, SafeTrack, secured funding, and safety oversight.

Mr. Corcoran thanked the members for volunteering and look forward to receiving input in the future.
