# **Certification News & Updates**

The SBPO certification unit has been receiving and processing applications for the new programs since June 2nd. Businesses approved by WMATA for one or more of the new programs are identified/labeled in the DCUCP vendor directory as "MBE", "SBP" and/or "MBP". In addition, SBPO is currently working with certain Departments to identify upcoming locally funded procurements for potential inclusion of MBE subcontract goals.

Shortly after the first of the year, SBPO began marketing the new programs both internally and externally via a number of outlets, including targeted business outreach/training sessions, utilizing existing connections with sister agencies, surveys, focus groups, internal management/planning meetings, and email marketing campaigns directed towards existing DBE certified businesses.
