

Solicitation Instruction # 8 "Preparation of Bids" paragraph d. is amended to read "Submittal of a price on all items in the Price Schedule is not required, bidders shall insert the words "NO BID" in the space provided (comments column) for any item for which <u>no</u> price is submitted. 2. The entire worksheet is password protected. However columns K, L, M, O, and P are not password protected and vendors must complete these columns. Vendors must put their bid prices in column M (unit prices).
