MTPD Uniforms and Accessories

Introduction

The Washington Metropolitan Area Transit Authority (WMATA), Metro Transit Police Department (MTPD) needs a contractor to provide police uniforms and equipment to approximately six hundred twenty five (625) sworn and active police officers and recruits on an as-needed basis.

Background

The MTPD workforce is dispersed throughout the Washington Metro region. MTPD operates 7 facilities in the District of Columbia, Virginia, and Maryland. The MTPD headquarters is located in the District of Columbia. The potential vendor shall provide at a minimum an e-commerce distribution solution that covers the extent of the region. Consideration shall also be given to showroom locations (e.g. mobile or fixed) for distribution and transactions within a 35 mile radius of corporate headquarters.

MTPD is a Tri-jurisdictional police department that has arrest power throughout the 1,500 square miles of the Transit zone that includes Maryland, Virginia and the District of Columbia. MTPD currently has four (4) uniforms for sworn members and two (2) for Special Police are issued. These are customized uniforms for the department.

The Class "A" uniform is the ceremonial uniform consists of a fully buttoned long sleeve white shirt which has the MTPD patch, badge, nameplate, "MTP" insignia and the appropriate insignia based on rank (i.e. Chief, Deputy Chief, Captain, Lieutenant & Sergeant).

The Class "B" uniform is the same uniform as the Class "A" uniform, with the option of being worn with a long sleeve or short sleeve white shirt.

The Class "C" uniform is the utility uniform or what is called a BDU. This uniform includes a name plate (metal) or a name tape (embroidered), cloth badge, rank of Sergeant should be sewn. The final uniform is the Class "D" uniform which is a high visibility uniform. The uniform shirt is a dri-fit material, two tone color (upper neon yellow, lower portion is a navy blue). The uniform is similar to the Class "C" has a patch on the shoulder and an embroidered name tape. The pants are a navy blue pants and/or shorts.

In 2016 the MTPD implemented a high visibility Class D uniform as part of the General Manager's FY2017 Customer Accountability Report (CARe). MTPD successfully met the initial needs of the department for the high visibility Class D uniform through a US Communities vendor. MTPD intends to transition to a Quartermaster system where quantities and deliveries will be indefinite over the next 5 years.

1. Requirements Contract

MTPD will purchase its requirements of the articles or services included herein from the Contractor. The estimated quantities stated herein reflect the best estimates available. The estimate shall not be construed as a representation that the estimated quantity will be required or ordered, or that conditions affecting requirements will be stable. The estimated quantities shall not be construed to limit the quantities which may be ordered from the Contractor by the MTPD or to relieve the Contractor of its obligation to fill all such orders.

- a. There is no limit on the number of orders that may be issued. MTPD may issue orders requiring delivery to multiple destinations or performance at multiple locations. If the MTPD urgently requires delivery before the earliest date that delivery may be specified under this contract, and if the Contractor shall not accept an order providing for the accelerated delivery, the MTPD may acquire the urgently required goods and equipment from another source.
- b. Any order issued during the effective period of this contract but not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and MPTD's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period. Provided that the Contractor shall not be required to make any deliveries under this contract after the expiration date of contract.

2. Price Schedule - Requirements

The Contractor shall provide the manufacturer name, stock number and fixed unit bid prices for the line item specified in Section 2.a of the solicitation and in accordance with technical product specifications.

SPECIFICATIONS/WORK STATEMENT

Scope:

The Washington Metropolitan Area Transit Authority (WMATA), Metro Transit Police Department (MTPD) needs a contractor to provide police uniforms and equipment to approximately six hundred twenty five (625) sworn and active police officers and recruits on an as-needed basis.

MTPD's objective is to purchase uniforms and equipment during various timeframes. The Contractor is responsible for providing same day services, have a variety of on-the-shelf stock sizing with the ability to provide additional sizes with a short "turn-around" period and maintain sufficient stock on hand to provide a significant portion of MTPD officers with the required supplies and equipment in the event of an emergency.

General Requirements

- 1. The Contractor shall conform to the product specifications and guarantee that all garments will fit and satisfy authorized representatives in accordance with the specification of this contract.
- 2. The Contractor shall ensure that all uniforms and equipment delivered comply with the technical specifications described in the Deliverables Section.
- 3. The Contractor shall safeguard all items. All missing items shall be reported within 24 hours of noticing their disappearance to the COTR.

- 5. The Contractor shall maintain a composite stock of uniforms to equal a minimum of twenty percent (10%) of the total annual requirements at contractor's own secured facility site. At the start of the last month of this contract and option years, the composite stock may decline to ten percent (5%) of the total annual requirement. MTPD will not purchase remaining stock at the end of the contract or option years.
- 6. The Contractor shall fulfill uniform and equipment work order requests upon receipt of an official voucher form indicating an expiration date 14 calendar days from the issuance date. The Contractor shall not honor any expired voucher forms without prior approval of the COTR.

- 7. The Contractor shall provide a facility that is capable of performing alteration for uniforms during the term of the contract. Alterations shall include services. The Contractor's facility shall be set up in a manner that will allow authorized personnel to walk-in and have their measurements taken for new uniforms or to exchange a product item due to incorrect clothing sizes and flaws. The Contractor's facility shall serve as the central location site for fitting, alteration, and distribution of uniforms. The facility shall include at a minimum, the following:
 - a. The facility shall be open for business from 8:00 a.m. through 5:00 p.m., Monday through Friday.
 - b. The Contractor shall maintain experienced and qualified personnel to fit the uniforms and make required alterations of uniforms, as deemed necessary. Fittings and alterations must be completed no more than 10 calendar days from initial order.

Delivery

- 1 The Contractor shall not deliver uniforms or equipment to any person(s) other than those duly authorized to receive said goods. Goods delivered to unauthorized personnel will not receive payment and solely at the contractor's own expense. The Contractor shall immediately notify the CA of requests for any unauthorized delivery orders and report any unauthorized deliveries for security purposes.
- 2 The Contractor shall deliver all items ordered in accordance with the WMATA/MTPD general order standards for uniforms and equipment. In addition the Contractor shall ensure authorized items are available at the Contractor's location for pick-up.
- 3 MTPD will return any garment received in unusable condition to the Contractor at the Contractor's expense for replacement.
- 4 The Contractor shall ensure all shipped and delivered merchandise, throughout the duration of the contract, contains a detailed packing slip to include the Officer's Name, Item numbers and quantities.
- The Contractor shall offer access to a web-based shipment tracking system on all orders shipped through any package delivery company or postal service agency. The web based access should provide an ordering history archive and monthly report of ordering history.

- The Contractor shall prepare and submit a monthly voucher report detailing the quantity, type of voucher received, cost and date issued. The report shall be issued by the 15th of each month. The report shall be placed in a MS-Excel spreadsheet format and be transmitted electronically to the COTR.
- 7 The Contractor shall not exceed twenty-one (21) calendar days in completing all backorders.

Brand Name or Equal

- 1. As used in this clause, the term "brand name" includes identification of products by make and model.
- If items called for by this IFB have been identified in the schedule by a "brand name or equal" descriptions, such identification is intended to be descriptive, but not restrictive and is to indicate the quality and characteristics of products that will be satisfactory.
- 3. Bids offering "equal" products will be considered for award if such products are clearly identified in the bids and are determined by the WMATA/MTPD to be equal in all material respects to the brand name products referenced in the IFB.
- 4. Unless the bidder clearly indicates in his bid that he is offering an "equal" product, his bid shall be considered as offering a brand name product referenced in the IFB.
- 5. If the bidder proposes to furnish an "equal" product, the brand name, if any, of the product to be furnished shall be inserted in the space provided in the IFB, or such product shall be otherwise clearly identified in the bid.
- 6. The evaluation of bids and determination as to equality of the product offered shall be the responsibility of the WMATA/MTPD and will be based on information furnished by the bidder or identified in his bid as well as other information reasonably available to the purchasing authority. **CAUTION TO BIDDERS:** WMATA/MTPD is not responsible for locating or securing any information which is not identified in the bid and not reasonably available to the WMATA/MTPD.
- 7. Accordingly, to insure that sufficient information is available, the bidder must furnish as a part of his bid all descriptive material (such as cuts, illustrations, drawings, or other information) necessary for the MTPD to:
 - a. Determine the product offered meets the requirements of the IFB, and
 - b. Establish exactly what the bidder proposes to furnish and what the MPTD would be binding itself to purchasing by making an award. The information furnished may include specific reference to information previously furnished or to information otherwise available to the MTPD.

- 8. If the bidder proposes to modify a product so as to make it conform to the requirements of the IFB, it shall:
 - a. Include in its bid a clear description of such proposed modifications, and
 - b. Clearly mark any descriptive material to show the proposed modifications.
- 9. Modifications proposed after bid opening to make a product conform to a brand name product referenced in the IFB will not be considered.

Requirement for Descriptive Literature (ALREADY IN THE TEMPLATE

- 1. Descriptive literature must be furnished as a part of a bid and must be received before the time set for opening bids. The literature furnished must be identified to show the items in the bid to which it pertains. The descriptive literature is required to establish, for the purpose of bid evaluation and award, details of the products the bidder proposes to furnish as to design, material, quality, construction and performance characteristics.
- 2. Failure of descriptive literature to show that the product offered conforms to the specifications and other requirements of this invitation for bids may require rejection of the bid failure to furnish the descriptive literature by the time and ate set for receipt of bids will require rejection of the bid, except that if the materials are transmitted by mail and received late, it may be considered under the provision for considering late bids, as set forth elsewhere in this invitation for bids. The Contract Administrator may waive the requirement for furnishing descriptive literature if either of the following occurs:
 - a. Bidder states in the bid that the product being offered is the same as a product previously or currently being furnished to the WMATA/MTPD; or
 - b. The CA, on advice of technical personnel determines that the product being offered by the bidder complies with the specification requirements of the current invitation for bids.

Bid Samples

- Except where a designated brand name item is bid, bid samples must be furnished as part of the bid and must be received by the time specified for receipt of bids. Failure to furnish samples on time will require rejection of the bid, except that a late sample sent by mail may be considered under the Late Submissions procedures outlined in this solicitation.
- 2. Bid samples will be evaluated to determine compliance with the characteristics listed. Failure of these samples to conform to the required characteristics will require rejection of the bid.
- 3. Unless otherwise specified in the solicitation, bid samples shall be submitted at no expense to the WMATA/MTPD. Bid samples will be returned to the bidder only at the bidder's request and at its sole expense.
- 4. At the discretion of the CA, the requirement for furnishing bid samples may be waived for a bidder if the bid states that the offered product is the same as a product furnished by the bidder in connection with a previous contract.

Technical Product and Equipment Specifications

The Contractor shall provide MTPD with approved uniforms and accessories as stated in the following:

- 1. The Class "A" uniform shall consist of:
 - a. A fully buttoned ceremonial blouse, and nameplate centered one-eighth (1/8) inch above the left pocket;
 - b. A "MTP" lapel insignia on the blouse that is horizontally centered one quarter (1/4) inch above the upper point of each lapel;
 - c. The member's appropriate insignia, including Sergeants, on the blouse epaulette centered one-quarter (1/4) inch from the sleeve seam;
 - d. A collared long sleeve white dress shirt with the cuffs fully extended and buttons fastened;
 - e. A dark blue tie (Standard sizes up to 58 or 62 inches);
 - f. Blue pants with blue and gold leg stripe:
- 2. The Class "B" uniform is the same as the Class "A" except the blouse is not worn and members may a short sleeve white shirt without a tie.
 - a. A blue baseball style cap with a yellow or gray embroidered badge in the center may also be worn with the Class "B" uniform;

- b. Wigwam thermolite cap in Dark Blue (IS AN EMBLEM TO BE EMBROIDERED ON THE CAP?) "MTPD" Embroidery Gold or Silver Stich
- 3. The Class "C" is the utility uniform, or the BDU.
 - a. Name tape and Sergeant's stripes;
 - b. The name tape shall have the first initial and last name of the member stitched in gold or white thread and lettering must be ½ inch in height. The name tape must be flush with the top edge of the shirt pocket;
 - c. The gold or white embroidered badge will be centered one-half (1/2) inch above the left shirt pocket;
 - d. Metal gold in color pin-on chevrons for Police Officer 1 and 2 that shall be worn at the end of each collar, one-quarter (1/4) inch above the outside edge (other ranks on the epaulets);
 - e. Sergeants shall wear the tri-color sewn on stripes on the sleeve;
- **4.** A blue service hat with an area available in the front center to place a "cap plate". Members have the option to wear the issued service hat.
 - a. Grommets shall not be removed or shortened in circumference;
 - b. Officials shall wear gold colored cap bands on the front of their service hats and wear the hat that reflect their rank;
 - c. Female members are authorized to wear either the female or male service hat;
- The Class "D" uniform consists of:
 - a. Approved Hi-Vis yellow and dark navy blue shirt in short sleeve or long sleeve;
 - b. Hi-Vis yellow shirt shall include a Velcro name tape with the first initial and last name of the member stitched in white, a while and silver embroidered badge and 2 silver and black "MTPD" patches.
 - c. Machine washable Dark Blue or Navy Side-Pocket law enforcement grade athletic fit pants with extra cargo pockets.
