## **SPECIFICATION FOR SNOW AND ICE REMOVAL CONTRACT**

### **1. WORK TO BE PERFORM:**

WMATA requires the service of qualified contractors to remove snow and ice from the entrances, Exit roadways, bus lanes and parking lots that serve the facilities of the Metrorail stations in Washington DC, Maryland and Virginia. The contractor will furnish equipment (with qualified operators). Commencement of work and specific work location sites will be directed by the Contracting Officer's Technical Representative (COTR(s)). A listing of Alternate COTR(s) will be made available upon contract award. All work done under this contract will be paid on an hourly basis for each piece of equipment that is used.

The contract will be for a Base Year period and four (4), one (1) year options.

**Site Area Locations for coverage attached herewith.**

### **2. PRIORITIES:**

The following list sets forth the Order of Priority in which snow removal shall be accomplished;

- a. Entrance and exit roadways of rail stations
- b. Bus loops
- c. Kiss & Ride and Rail Station parking lots.
- d. Bus garages and other non-revenue facilities

### **3. EQUIPMENT**

The types of equipment must be approved by the COTR(s) at the beginning of each snow removal operation. The number of pieces of equipment to be used will also be determined by the COTR depending on the severity of the storm, up to 12 pieces. All equipment supplied must be in good working order and furnished with a qualified operator. The equipment may consist of any combination of four wheel drive pick-up, five ton dump trucks and 10 wheel dump trucks, all of which must be equipped with snow plows and some designated dump trucks must be equipped with broadcast spreaders. ***The bulk salt and sand will be made available to the contractor locally or from WMATA stock located at designated WMATA rail yards. Contractors are not required to salt.***

### **4. REPORTING REQUIREMENTS:**

Upon receiving notifications to commence snow clearing operations; the contractor's employees will report to the designated work site, and immediately call the PLNT Command Center at (301) 618-1116 and report the arrival time. Under all but extreme conditions the Contractor's employees and equipment must arrive on site and commence operations no later than three (3) hours after notification. Contractor's operators are not allowed to report and begin work before the request start time.



Request for services will be initiated by phone calls from designated COTR(s). At that time contractor(s) will be advised of the mode of operation (standby mode, regular operations or blizzard mode) Thereafter a spreadsheet with a listing of required equipment and quantities will be faxed to the Contractor.

The Contractor's employees will report to designated Alt. COTR location at the start of operations and will be released by the Alt. COTR after the satisfactory completion of work.

Contractor's equipment and personnel will be readily available to respond to WMATA's request for service. The Contractor shall have sufficient equipment and personnel to handle multiple priorities and conditions concurrently.

At time of arrival, the minimum length of a work shift will be four (4) hours. There is no maximum length of work shift. No guarantee is made of the number of consecutive shifts that may be required in any given time frame. The severity of the prevailing weather conditions and the needs of WMATA will determine these factors.

Standby Requests- When standby mode of operation is requested by WMATA, the Contractor's personnel and equipment must report to the job site within three (3) hours after notification from WMATA and wait for dispatch. Standby costs are incurred beginning once the contractor's employees arrive on site ready for dispatch.

#### 5. COMPUTATION OF HOURS:

- a. The hourly rate for each piece of equipment will start after the operator checks in with the COTR at the site and upon commencement of clearing operations at the work site. **Travel to and from the assigned work site will be at the contractor's expense.** The contractor must notify the PLNT command center on (301) 618-1116 if any employee and or equipment leaves the work site or stops work due to equipment failure for any reason
- b. The hourly rate will stop when the COTR(s) determines that sufficient services have been perform with a minimum of four (4) hours to be paid for mobilization for each piece of equipment regardless of the number of hours worked at each site. The four (4) hour minimum may consist of two (20 hours standby and two (2) hours of plowing operations when standby has been requested. The standby rate will be equal to one half of the per hour rate.
- c. **Blizzard Conditions:** This is an option requirement and is based on a declared Emergency by WMATA's CEO. In this event contractor(s) will be notified and advised of blizzard conditions and required to provide off road equipment to WMATA job requested sites. Equipment to be provided includes backhoes tractors or bobcats.

Relocation of off road equipment will be charged in the following manner:

If WMATA requires the contractor to bring off-road equipment to WMATA job sites, the Contractor may invoice WMATA for relocation cost of off-road equipment from the contractor's site to the initial WMATA job site. **No cost for returning equipment to contractor's job site will be paid. Cost for transporting this equipment to initial job site shall not exceed the cost charged for 2-hours service for such equipment.**

## **6. GENERAL INSTRUCTIONS:**

The following are general requirements:

- a. Care shall be exercised so that parked vehicles are not blocked with snow. If cars are blocked with snow by the Contractor's workers, the Contractor shall be responsible for hand shoveling cars out.
- b. All paved roadways, parking lots and maneuvering areas are to be plowed.
- c. No snow shall be pushed into or on any public streets.
- d. The Contractor shall exercise care in the direction the snow is plowed, so that adjacent sidewalks are not covered with snow. Contractor shall make site visits to stations prior to snow season and follow the plowing plans provided by WMATA.
- e. Contractor shall employ all necessary safety precautions to prevent injury to persons or damage to property and equipment. If at any time WMATA determines that proper safety measures are not being employed, the Contractor will be stopped from working and can resume work only at such time as the condition is remedied to the satisfaction of WMATA.
- f. All operators assigned to snow removal duties with WMATA shall be qualified to operate their equipment, Operators will respond to COTR(s) instructions.
- g. Contractor's employees shall not use or be under the influence of alcohol, drugs, or other controlled substances while performing work for WMATA or physically on WMATA leased or owned property.
- h. Contractor is responsible for ensuring that Contractor's employees perform services in accordance with WMATA standards for safe operation of equipment and safe handling of chemicals.
- i. Parking lots will be plowed completely to curb or bumper blocks. Lots will be left clean and free of snow. Contractor shall not plow snow onto sidewalk or in front of drive ways. Do not block handicap ramps.
- j. Major snowfalls or accumulations of snow may reach a point that makes plowing ineffective due to buildup of plowed snow or ice around parking areas, making physical removal of the snow necessary. The decision to remove the snow for transport to another location will be made by COTR(s). Locations for disposal will be determined by COTR(s).
- k. Contractor's trucks and equipment must be in good working order to manage breakdowns and arrive on site with the proper amount of fuel to work the assigned snow plow assignment.
- l. The snow plow operator's must put forth a good and consistent effort to accomplish the snow removal operation.
- m. Each truck and / or equipment sent to a designated job site must have a company supplied job ticket to be presented to the WMATA representative at the work location.

- n. Each operator may receive further instructions for additional work areas upon completion of a given work area. The operator must make a reasonable effort to contact the WMATA Representative for additional assignments after they have completed a given work area. The operator must put forth a good and consistent effort to accomplish the snow removal operations.
  - o. Each operator must have at least one company job ticket but not less than three available tickets per call out.
  - p. Each operator shall make a reasonable effort to contact and present the job ticket to the WMATA representative to close out the job assignment.
  - q. ***WMATA reserves the right to request services based upon weather conditions in various locations.***
  - r. ***WMATA reserves the right to add or delete locations based on the needs of the Authority.***
7. ***SUB-CONTRACTS:***  
***The Contractor shall not sub-contract snow and ice removal work for this contract unless prior approval is obtained from WMATA's Contracting Officer.***
