QUESTIONS FROM THE INDUSTRY AND WMATA'S RESPONSES

1. The drive assembly has 2 rotors (rotor A & rotor B) Will these rotors be included in the assembly for inspection as well or will it be removed from the assembly prior to pick up? The Statement of Work does not specify any work for the rotor.

Answer: WMATA does not have a method to remove or install the stators from the housing therefore each drive assembly will have two rotors included.

2. Pricing should include delivery and pick-up of the HP drive units, do you have the address of where these units will be picked up and delivered?

Answer: The address is Carmen Turner Facility location only, 3500 Pennsy Drive, Hyattsville, MD 20785

3. Will there be any uninstallation/installation involve when picking up the drive units from its mounting base?

Answer: No, units are shipped on pallets.

Or will the units be uninstalled and ready for pick-up?

Answer: Yes, units are shipped on pallets.

4. WMATA states that new stator and lugs will be provided. Will you also provide other parts such as gaskets, O-rings and seals? If not, can you provide a parts breakdown diagram and parts list of the drive unit?

Answer: No gaskets, O-rings, or seals are necessary.

5. Would it be possible to have a site visit to have an actual view/inspection of these hybrid drives prior to submission of bids.

Answer: No, because it is not required to submit a bid.

6. The Vendor wants to do a site visit " to get acquainted with Allison hybrid drive units".

Answer: No, because it is not required to submit a bid.

7. Is it possible to provide a detailed Bid of Material along with the manual instructions for Allison hybrid drive unit?

Answer: See Appendix D under Amendment No. 1.

The base period of performance is one year from contract award. Any option period, if exercised, shall have a one year period of performance and shall be exercised, if at all, immediately upon the expiration of the prior base or option period.

The estimated quantities are WMATA's best estimate of the quantities of services that will be required for the repair and replacement of stator housings. Do not change the estimated quantities. The Offeror must submit fully loaded prices for the requirements.
