1. Is a Performance and Payment bond required?

No performance and Payment bonds are not required.

2. Can submission of COI with the bid be waived until the Contract is awarded?

No. In order for RISK to accept or tentatively accept the insurance we need to review the current insurance from the prospective vendor. If there is a coverage that the vendor doesn't have, a letter from the vendor's broker confirming that the insurance WILL be procured upon contract award will suffice.

3. Is the \$5,000,000 MCS-90 Endorsement required?

No. MCS-90 is required when transporting/disposing of hazardous waste and material. The materials outlined in the SOW didn't appear to meet the threshold of hazardous (per EPA guidelines), therefore I didn't require the endorsement

4. SOW #5 requires exterior side of windows to be cleaned. Will this be excluded?

Scope of Work, Deliverables, Cleaning Responsibilities will consist of: #14, Page 4 of 14 states:

"Windows should be cleaned inside and outside with approved glass cleaner" is REVISE to:

"Windows should be cleaned inside only with approved glass cleaner."
