## AMENDMENT OF SOLICITATION CQ16051/CDS Psychological Testing for METRO Transit Police Officer Applicants

## I. Below are questions and responses:

- Q1. Can you kindly provide the name of current vendor and price per pre-employment psychological evaluation? Response: The contractor name and unit price is not public information. The Authority paid over \$28,000 during a 6 month period for these services.
- Q2. I am unclear as to why there is a requirement for financial statement, since the proposal work requires minimum materials cost and no credit on the contractor's part and carries no risk for WMATA. Please advise whether or not this is, in fact, required for this type of contract. Response: Financial statements are required per the Pre-Award Evaluation Data section. Financial statement are one of several supporting documents used in determining Responsive and Responsible offerors.
- Q3. Will any preference be given for small local businesses? It is unclear whether Attachment A applies specifically to this solicitation. If the offeror is not certified as an SBLPP, but obtains the certification prior to the due date, please confirm that this counts. If the offeror is not registered or cannot obtain the SBLPP certification, please confirm whether they must provide justification with grant of relief waiver with good faith effort reporting as detailed in Attachment A. Response: Attachment A does not apply to this requirement.
- Q5. With the technical proposal a "sample of tools/instruments" is requested. Please clarify if a listing of tools/testing instruments utilized is sufficient or if an actual test packet is required? **Response:** Offerors shall provide an actual test package that will be used in the technical proposal.
- Q6. Key Personnel Qualifications can the lead doctor (who has many years of experience) utilize psychologists with fewer than 7 years of experience to perform examinations/interviews as long as they are supervised? The lead doctor would be ultimately signing off on every case. **Response:** No.
- Q7. Please clarify requirements under performance schedule and deliverables (page 79). An evaluation completion with a "final report" delivered to WMATA within 42 hours of completion and a "detailed report" of evaluation due within 7 days. Can a "preliminary report" be provided within 42 hours and a final, detailed report within 7 days? **Response:** Psychologist shall provide the following reports:
  - (a) Evaluation and Recommendation Report This report is due 42 hours after the interview.
  - (b) Detailed Report This report is due within 7 days of the interview and shall include details results and scores, detailing substance use history and the results of any instruments including Minnesota Multiphasic Personality Inventory (MMPI-2) and copies of the actual evaluation tools/instruments.

Both reports are final reports and cannot be changed.

- Q8. Please clarify what you require under Deliverables #1? Response: See response to question 7.
- Q9. What is the expected date when will award be given? Response: The Authority anticipates making an award within 90 days.
