QUESTIONS RECEIVED FROM VENDORS AND WMATA'S RESPONSES

- 1. We partner with a drug screening provider and utilize all of the clinics in their network as well as the MRO. Is that acceptable to meet the requirements of this RFP?
 Answer: Applicants/employees must be able to receive examination and drug/alcohol screening at the same location.
- 2. For the site visit of facilities, can we give you a list of facilities in the DC, MD and VA area that we use for Periodic Medical evaluation and non-dot/DOT drug and alcohol testing?

Answer: Yes

3. Will you be requiring Random DOT drug testing?

Answer: No

- 4. If you require random DOT drug testing, will this be scheduled as an **onsite visit** at one of your main locations, or will we be scheduling the random tests at one of our in network clinics?

10. Page 88, 2.1 indicates Saturday hours are required. Is this to mean every Saturday or only when examinations are scheduled?

Answer: Examinations are scheduled every Saturday

11. Is there an expectation that walk-ins (vs. scheduled appointments) will be required for DOT examinations?

Answer: No Walk-ins

12. Page 95 indicates a web based system to provide status and additional information. In addition, daily and monthly reports are required. Would it be sufficient to have the web-based system produce this information on a daily and monthly basis?

Answer: Yes

13. Page 98 lists multiple medical follow up screenings including 45 day, 30 day and 10 day follow up. What is the expectation on how contractor staff will follow up with TA personnel? Will the contractor have access to the individuals phone numbers, etc.

Answer: Contractor will communicate with TA via required Daily Status Reports. Phone numbers will be made available.

 Answer: It is not AECOM. Rather it is ACOEM guidelines. DOT examinations as per federal regulations. Safety Sensitive examinations include titmus vision screen, audiogram, dipstick urinalysis, drug and alcohol screen, screening for sleep apnea, vital signs, BMI, review of medical history physical examination assessing ability to perform essential functions as per WMATA Job Descriptions, and determination of ability to perform essential functions.
- 27. Please articulate what is included in the litigation package (pages 6 and 7)

 Answer: Urine drug test litigation package includes: Copy of external CCF; Copies of internal chains of custody; Screen results; Confirmation results; Donor ID verification; Photo copy of bottle seals; Copy of MRO results; Certified scientist worksheet; Specimen storage record.

 Breath alcohol litigation package includes: EBT calibrations.

 **Answer: No. Drug screens should include IA and GC/MS. Split testing offered for confirmation of non-negative.

 Breath alcohol litigation package includes: EBT calibrations.
