Description of Work

Estimated Cost Range: \$5,000,000 - \$15,000,000

Bids Due: On or about June 10, 2015 and shall be delivered to WMATA, Office of Procurement and Materials, Room 3C-02, 600 Fifth Street, NW, Washington, DC 20001.

Pre-Bid Conference and Site Visit, On or about May 20, 2015 at WMATA, Jackson Graham Building, Lobby Level Meeting Room, 600 5th Street, NW, Washington, D.C., 20001. WMATA will provide a presentation including the solicitation issues and technical requirements.

WMATA will have representatives of our procurement, insurance, DBE, Safety, and infrastructure renewal in attendance. WMATA certified DBE's are strongly encouraged to attend.

All attendees must provide a WMATA Contractor ID or a government issued identification for entry into the Jackson Graham Building (cameras, cell phones, computers and other mobile devices are permitted). Individuals that plan to attend the meeting are requested, but not required, to send an email to ggufranova@wmata.com, 48 hours in advance, with their name, title, company name, mailing address, telephone, and email for each attendee. Attendees should arrive early in order to clear security and/or receive temporary badges.

Site Visit, WMATA will conduct a site visit at:

- the four (4) parking garages within the work limits of this Project,

Day one (1) Site Visit information: Site visit will start on Wednesday, May 20, 2015, 2.00 pm (14:00). Meeting point will be a pedestrian bridge in the Grosvenor-Strathmore parking garage at: 10300 Rockville Pike, Bethesda, MD 20852. Attendees will be required to sign in at both parking



garages. Site Visits. Site visit will continue at the north side outside of Shady Grove parking garage, located at 15903 Somerville Drive, Rockville, MD 20855

Day one (1) Site Visit is expected to finish around 5.00 pm (17:00).

Day two (2) Site Visit information: Site visit on day two (2) will start on Thursday, May 21, 2015, 9.00 am. Meeting point will be the kiss&ride lot of College Park Metrorail Station located at 4931 Calvert Road, College Park, MD 20740.

Attendees will be required to sign in at both parking garage Site Visits. The Site Visit will continue the same day with visiting Franconia Springfield parking garage at 6880 Frontier Drive, Springfield, VA 22150.

Day 2 Site Visit is expected to finish around 3:00 pm (15:00).

All attendees will be required to have with them OSHA approved safety vests, hard hats, safety glasses, and sturdy boots. Attendees that have a current WMATA Contractor ID shall display their ID and bring PPE and WMATA approved safety vest. Attendees not holding WMATA Contractor ID with PPE and vest should specifically identify themselves to the WMATA representative on site.

Attendees will be required to provide their own transportation for the Site Visit. If attendees use Metrorail system to get to the Site, they will be required to provide their own fare to ride the Metrorail System.

Should Site Visit plans change, updated information will be publicized on www.wmata.com at least 1 week prior to the Site Visit. The attendees need to check www.wmata.com regularly for the latest information on the Site Visit.

Period of Performance Anticipated to be 3.5 years

Bonds/Guarantees:

A bid guarantee, in the amount of 5% of the total bid price, is required with the bid if it is greater than \$100,000. The successful Bid must provide Performance Bond in the amount of the contract price after award of the contract and Payment Bond in the amount of 1) Fifty percent of the contract price if the construction contract price is not more than \$1,000,000; (2) Forty percent of the contract price if the contract price is more than \$1,000,000 and not more than \$5,000,000; or (3) When the contract price is more than \$5,000,000, the payment bond shall be \$2,500,000.

DBE Information:
