GENERAL STATEMENT OF WORK

The Contractor shall furnish all labor, materials, equipment, incidentals, and other items necessary to complete the Structural Retrofit of B9 Beam at Farragut North Metrorail Station as required by the Contract documents.

PERIOD OF PERFORMANCE AND PROJECT SCHEDULE

Interim & Final Work Completion: 365 calendar days

Milestone 1: Shop Drawings and Technical /Product Submittals – All shop Drawings and Technical or Products/Material submittals are to be submitted to WMATA at the 100% for final level of progression, NTP +75 calendar days

Milestone 2: Substantial Completion Form – All major construction activities are completed. Substantial Completion Inspection form is signed by WMATA COTR, NTP +270 calendar days



PERIOD OF PERFORMANCE AND PROJECT SCHEDULE

Milestone 3: Punch List Completed – Complete all punch list items. Site is fully restored and returned to WMATA for unrestricted use, NTP +300 calendar days

Contractor's access to the Farragut North Station platform shall be limited to no more than 170 calendar days from the first day of access to the platform to the completion of all punch list work.

Method of Procurement – This is a low bid procurement

The Authority will make a single award to one Bidder as the result of this Invitation. See Notes to Bidders in Section 00434, BID PRICE SCHEDULE, for further award information.

A written award of acceptance of Bid mailed or otherwise furnished by the Authority to the successful Bidder within the specified Acceptance Period shall result in a binding contract without further action by either party.

<u>Type of Contract</u> – The Authority contemplates award of a Firm Fixed Price contract

How WILL BIDS BE EVALUATED

The Authority will evaluate Bid Price for completeness, clarity, conciseness, realism, and responsiveness to the IFB requested information

Materially unbalanced prices: Bids that are materially unbalanced as to prices for the various categories of work items may be rejected as non-responsive



How WILL BIDS BE EVALUATED

The Authority will compare the Bid Prices to the Authority estimate and otherwise determine reasonableness by performing a price analysis if adequate competition exists. A cost analysis will be performed, if adequate price competition does not exist, to ascertain whether or not the proposed price is fair and reasonable. The Authority may request that Bidders provide a cost breakdown, which identifies major cost drivers and request supporting documentation, such as Supplier and Subcontractor quotes in support of the Bid.
