Location

Address: 7901 Cinder Bed Road; Lorton, Virginia 22079. The facility is located near the Interstate 95 interchange with Fairfax County Parkway (north of Fairfax County Parkway, east of Interstate 95), in the Newington portion of Fairfax County.

Service Area

Service assigned to this division primarily operates in Northern Virginia along the Interstate 95, 395, 495, and US-1 corridors; the Shirley Highway High-Occupancy Vehicle (HOV) lanes; and the 95, 395 (future), and 495 Express Lanes.

Major activity centers within the service area include Annandale, Burke, Burke Centre, Fairfax, Fort Belvoir, Lincolnia, Old Town Alexandria, Springfield, and Vienna. Rail stations within the service area include all Blue and Yellow Line Metrorall stations and core Virginia Railway Express commuter rail stations in Virginia.
