Active Solicitations

AC Switchgear State of Good Repair - Package 2

The work includes constructing the project as indicated in the forthcoming Solicitation documents. The Design-Builder shall be responsible for all materials, labor, transportation & handling, construction equipment, tools, and all other incidentals necessary for completion of the work. The work to include, demolishing and installation of new AC switchgear lineups and associated equipment and devices (i.e. bus-tie cables, bus duct, feeder cables, conduits, panelboards, low voltage transformer, lighting, and new battery cycle monitors) at nine (9) WMATA Passenger Stations and two (2) WMATA Rail Yards. In addition to the electrical work, efforts will also include elements of mechanical, structural and SCADA.

Delivery Method: Design-Bid-Build (DBB)
Potential Contract Value*: \$103M-\$114M

Solicitation: Active - Bids due September 14, 2023

Planned Solicitations



Bethesda Station South Mezzanine

Design and construction of a second mezzanine at Bethesda Metrorail Station, involving Structural, Architectural, Mechanical, Electrical, Fire Protection, Communications, and other elements of work. Adjacent to and above the south end of the WMATA's Bethesda Metrorail Station, Maryland Transit Authority (MTA) is constructing a new station on Elm Street in Bethesda for its new Purple Line (PRPL). The scope of this project includes adding a new mezzanine at the south end connected to the upcoming Purple Line entrance and containing the following primary elements: Precast stairs, two escalators, two elevators, pylons, a kiosk, exit fare machine, and fair gates.

Anticipated Delivery Method: Design-Build Potential Contract Value*: \$35M-\$50M

Planned Solicitation: Fall 2023 (Early September)

SBPO Participation**: Disadvantaged Business Enterprise

Fire Door Shutter at Forest Glen Metrorail Station Design

Perform Design & Engineering (D&E) services to determine existing conditions; develop 100% designs of a preferred alternative to bring system to State of Good Repair (SOGR); identify implementation risks; and develop an engineering cost estimate and schedule. The scope includes the design development of the Fire Shutter Replacement (Phase 1, Two Elevator lobby fire shutters), Fire Shutters at Emergency Stairwells Replacement (Phase 2), and Leak Mitigation.

Anticipated Delivery Method: Design Task Order

Potential Contract Value*: \$400K-\$900K

Parking Garage Rehabilitation - 2 Garages

Rehabilitation of two parking garages (Shady Grove & another location to be confirmed) to bring them into a state of good repair, including structural repairs.

Anticipated Delivery Method: Design-Bid-Build

Potential Contract Value*: \$10M-\$20M

Planned Solicitation: Fall 2023

SBPO Participation**: Disadvantaged Business Enterprise

Permanent Generator System Replacement

Replacement of 19 permanent diesel generators identified as priority locations based on limited replacement part availability that affects equipment functionality and maintainability. These generators range from 50kW to 600kW and are connected to various electrical systems supporting Metro stations, Parking, and Bus Garages.

Anticipated Delivery Method: Design-Build Potential Contract Value*: \$20M-\$30M

Planned Solicitation: Fall 2023

SBPO Participation**: Disadvantaged Business Enterprise

Shaft Structural State of Good Repair Program - Package 1

Rehabilitation of ventilation and emergency egress shafts located in Metrorail tunnels, including structural and electrical elements within these shafts. The electrical equipment servicing the fans require replacement, this includes the motor control centers (MCCs), electrical disconnects, transformers, automatic voltage regulators (AVRs), local low-voltage distribution panels, transfer switches, and the power feeds back to the substations. Structural elements consist of the correction of concrete and steel defects, steel and concrete corrosion control, and groundwater infiltration migration.

Anticipated Delivery Method: Design-Build Potential Contract Value*: \$50M-\$60M

Planned Solicitation: Fall 2023

SBPO Participation**: Disadvantaged Business Enterprise

Surface Lot Rehabilitation - Four Lots

Rehabilitation of four surface parking lot facilities (Hyattsville Crossing, Twinbrook, Morgan Blvd, and Vienna), including Kiss & Ride lots and connecting roadways, to return these facilities to a state of good repair.

Anticipated Delivery Method: Design-Bid-Build (Designs ongoing)

Potential Contract Value*: \$8M-\$18M

Planned Solicitation: Fall 2023

SBPO Participation**: Disadvantaged Business Enterprise



Winter 2024

Cinder Bed Rd Bus Garage BEB Conversion

Design and modification of Cinder Bed Bus Garage, one of WMATA's newest Bus O&M facilities. With WMATA's transition to 100% ZEV bus fleet this facility is to be outfitted and modified to become an electric bus garage to store, maintain and operate battery electric buses.

Anticipated Delivery Method: Progressive Design-Build

Potential Contract Value*: \$120M-\$140M

Planned Solicitation: Winter 2024

SBPO Participation**: Disadvantaged Business Enterprise

Storage Tank Replacement Program - 3 Locations

Replacement of underground fuel storage tanks at the New Carrollton, Greenbelt, and Glenmont railyards.

Anticipated Delivery Method: Design-Bid-Build

Potential Contract Value*: TBD

Planned Solicitation: Fall 2023/Winter 2024

SBPO Participation**: Disadvantaged Business Enterprise

Traction Power State of Good Repair - Contract 2

Rehabilitation and upgrade of 14 Traction Power Sub-Stations and 21 Tie Breaker Stations along the Red line in Maryland and DC. In addition to traction power, the project includes the renewal of SCADA, mechanical, and electronic security and safety systems (e.g., Access Control and CCTV). An optional Battery Power Sub-Station is a modernization element at two (2) locations to capture and re-use train regenerative power for the traction power.

Anticipated Delivery Method: Design-Bid-Build Potential Contract Value*: \$165M-\$175M

Planned Solicitation: Winter 2024

SBPO Participation**: Disadvantaged Business Enterprise

The purpose of this Contract is to procure staff augmentation services, to assist with management and oversight for all Indefinite Delivery, Indefinite Quantity (IDIQ) task order contracts managed by the Metro's Infrastructure Department. The scope of work will include, but not be limited to, assisting with management and oversight of existing/new master/task order contracts, technical writing services, procurement support, providing business analytics, and providing procurement and contract management support.
