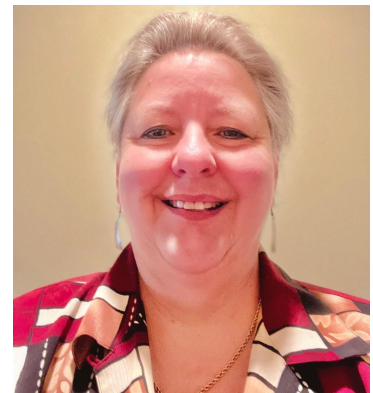

ARCHITECTURAL, ENGINEERING, AND CONSTRUCTION OPPORTUNITES



Automated Track Inspection Vehicle (ATIV) Infrastructure

Two vehicles have been procured with delivery starting in December 2024. Track infrastructure modifications are needed in the Service & Inspection (S&I) shop at the Brentwood Rail Yard in Washington, D.C. to store and maintain the vehicles. Design services are expected to proceed under Metro's GAEC IDIQ contract. Construction services will be procured following design services.

Chiller Upgrades and Plant Rehabilitation at 4 Facilities

Holistic replacement of chiller equipment and rehabilitation of metal supports and facility infrastructure to attain a state of good repair. Designs have been completed. The remaining scope of work is for construction at four chiller plant locations.



Anticipated Delivery Method: Design-Bid-Build
Potential Contract Value*: \$10M-\$15M
Planned Solicitation: Winter 2022/2023
SBPO Participation:** Disadvantaged Business Enterprise



Permanent Generator System Replacement

Replacement of 19 permanent diesel generators identified as priority locations based on limited replacement part availability that affects equipment functionality and



maintainability. These generators range from 50kW to 600kW and are connected to various Metro's electrical systems, including Stations, Parking and Bus Garages.

Anticipated Delivery Method: Design-Build

Potential Contract Value*: \$10M-\$15M

Planned Solicitation: Winter 2022/2023

SBPO Participation:** Disadvantaged Business Enterprise

Revenue Collection Facility

Rehabilitation of Metro's Revenue Collection Facility in Alexandria, VA, based on identified structural, mechanical, electrical, and plumbing state of good repair needs. Building condition assessment has been completed and designs are underway. The remaining scope of work is for construction at the facility.

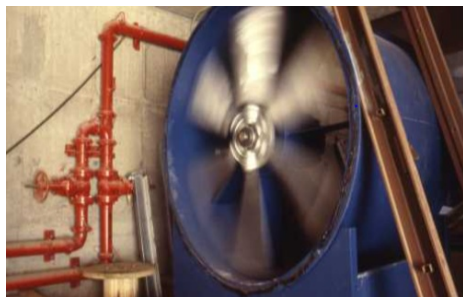


Anticipated Delivery Method: Design-Bid-Build

Potential Contract Value*: To Be Determined

Planned Solicitation: Winter 2022/2023

SBPO Participation:** Disadvantaged Business Enterprise



Shaft Structural State of Good Repair Program - Package 1

Rehabilitation of ventilation and emergency egress shafts, including structural and electrical elements within these shafts located in Metrorail tunnels.

Anticipated Delivery Method: Design-Build

Potential Contract Value*: \$35M-\$45M

Planned Solicitation: Summer 2023

SBPO Participation:** Disadvantaged Business Enterprise

Station Revitalization Program - Phase 1

Revitalization of 71 underground Metrorail stations in line with the Customer Experience Design Guidelines (CEDG). Fire-Life-Safety needs at 18 core stations have been identified for Phase 1, including fire alarms, CCTV, access control, Public Address systems, and intercoms.

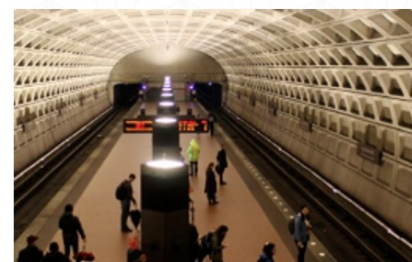


Anticipated Delivery Method: Design-Bid-Build

Planned Solicitation: Winter/Spring 2023

SBPO Participation:** Disadvantaged Business Enterprise





Traction Power State of Good Repair - Contract 2
Rehabilitation and upgrade of 14 Traction Power Sub-Stations and 21 Tie Breaker Stations along the Red line in Maryland and DC. In addition to traction power, the project includes the renewal of SCADA, mechanical, and electronic security and safety systems (e.g., Access Control and CCTV). An optional Battery Power Sub-Station is a modernization element at two (2) locations to capture and re-use train regenerative power for the traction power.

Anticipated Delivery Method: Design-Bid-Build
Potential Contract Value*: \$165M-\$175M
Planned Solicitation: Winter 2022/2023
SBPO Participation:** Disadvantaged Business Enterprise

Multiple Award Task Order Contracts (MATOC)

Metro issued an **Electrical Contractors MATOC** to support the ongoing capital program through competitive task orders for electrical work. The estimated contract value is up to \$15M per task order and the IFB has been published with bids due by 2pm EST on **October 5, 2022**.

Metro will also issue a **General Contractors MATOC** to support the ongoing capital program through competitive task orders for general construction services. The estimated contract value is up to \$5M per task order and the IFB is planned for publication in **Spring 2023**.

Both of these MATOCs anticipate SBPO participation.

PMCM IDIQ Master Contract

Metro has an Indefinite Delivery/Indefinite Quantity (IDIQ) master contract for Project

Management/Construction Management (PMCM) task order consultant services that conclude in August 2023. We will be re-competing this contract in **Winter 2022/2023** for a new 5-year period.

Requests for Information (RFI)

Metro has an active RFI on Pilot Switch Machines for Rail Switch Points with the deadline for responses extended to 2pm EST on **October 17, 2022**.

We will publish an RFI on **Intrusion Detection Warning (IDW) Systems** in the coming weeks to identify potential vendors and new technologies for Metro's rail track network.
