Noise Exceedances:

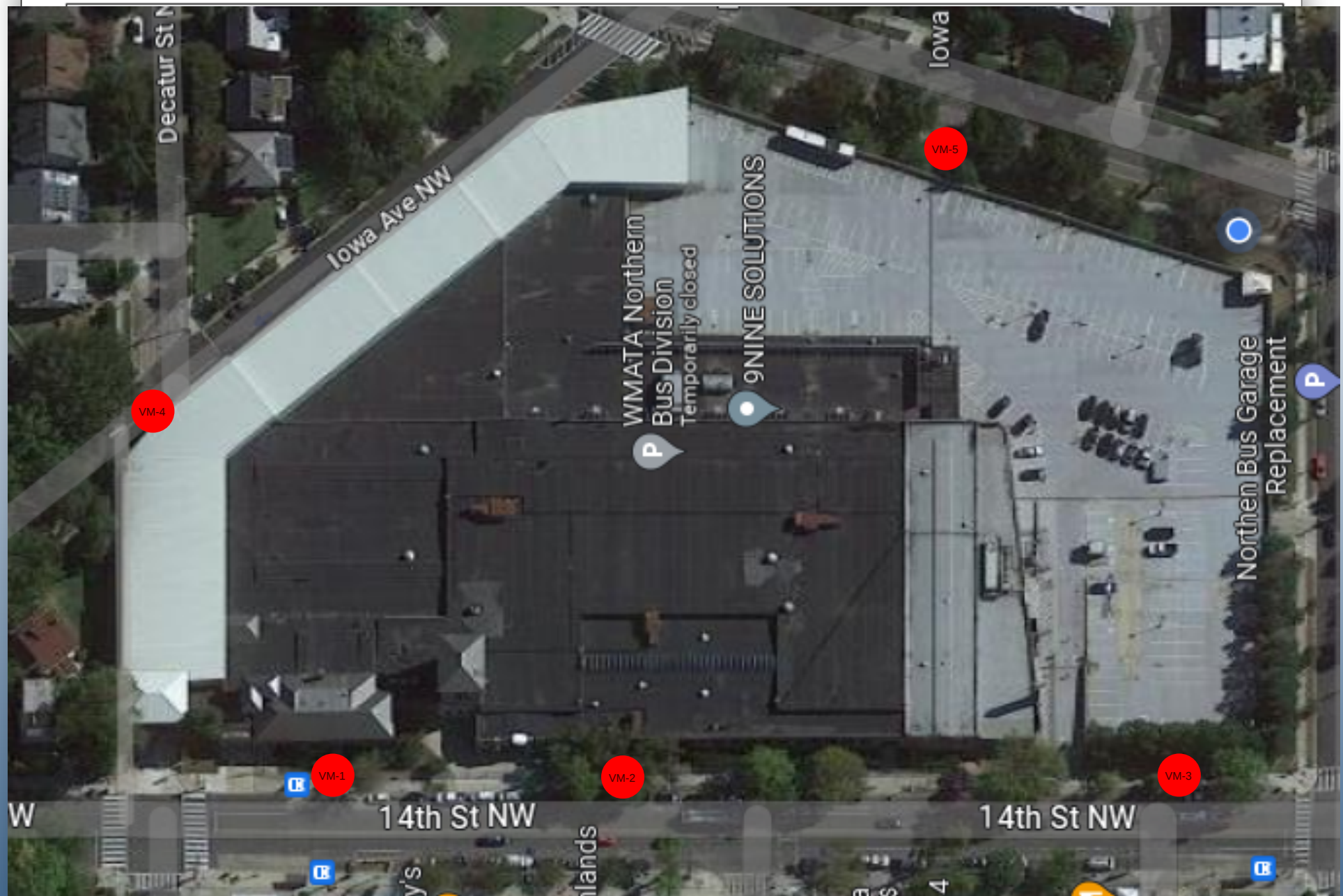
There continues to be numerous noise level exceedances at all hours of the day and all days of the week. Mic2 recorded the highest noise levels of any location after working hours and on weekends. In addition, Mic1 and Mic2 were similar to one another with 44% and 38% of the exceedances coming outside of working hours. Mic3 had 17% of its exceedances outside of working hours. Mic5 recorded 12% of its exceedances during nights and weekends. Mic54 had 9% of its exceedances outside of working hours.

There were no vibration exceedances in the month of August 2023.

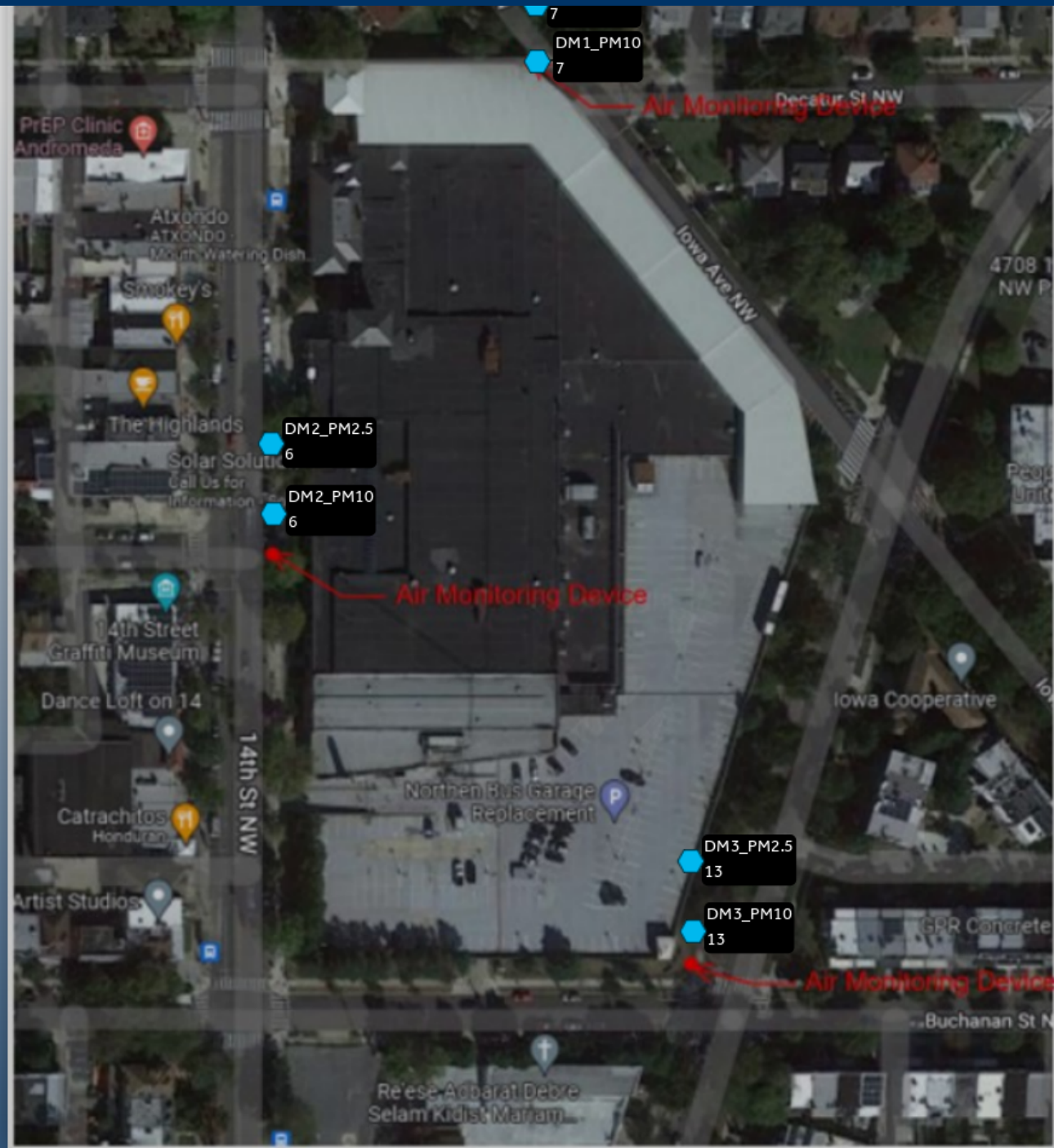
Air Quality/Dust Monitoring Exceedances:

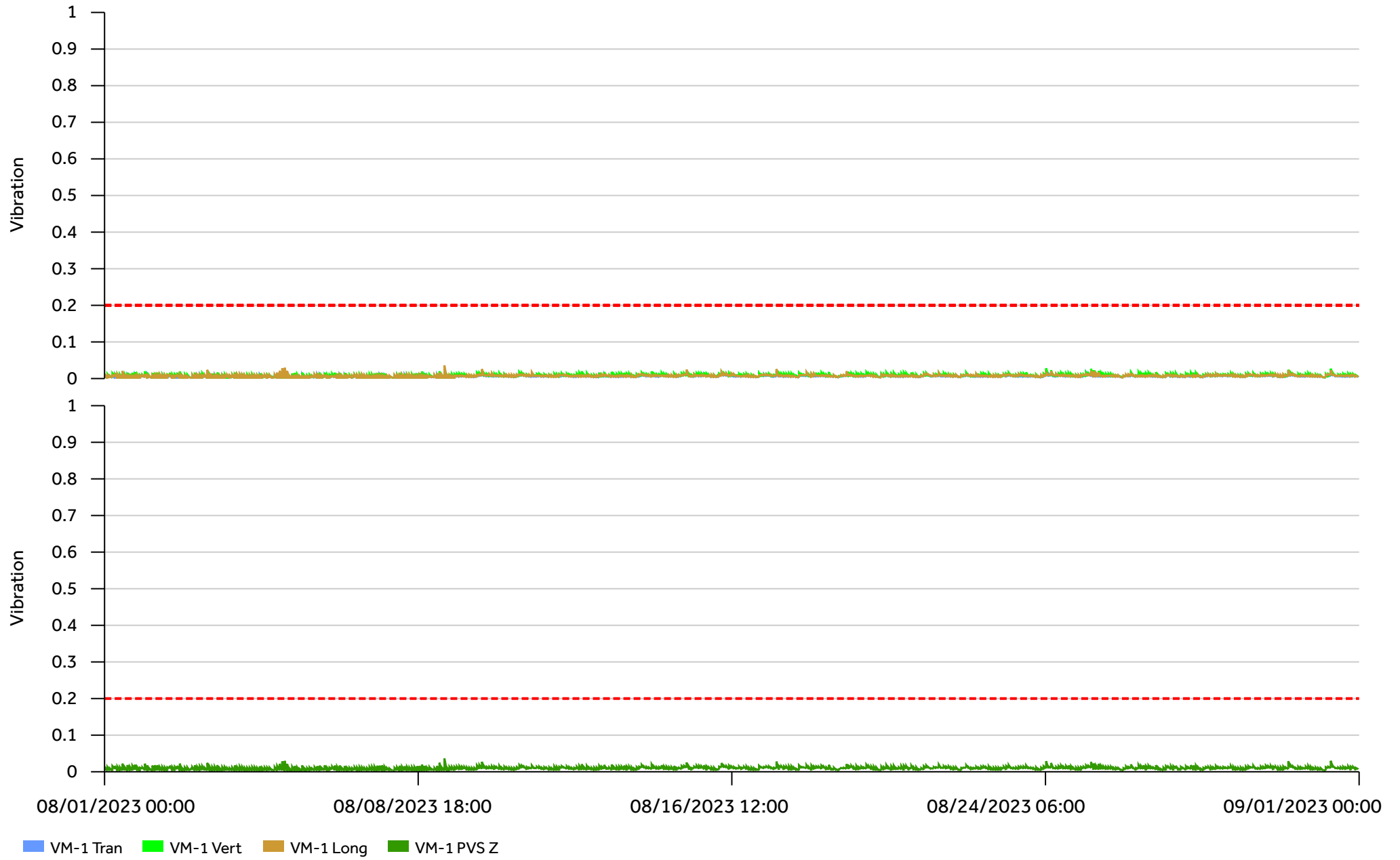
Air Quality Exceedances:

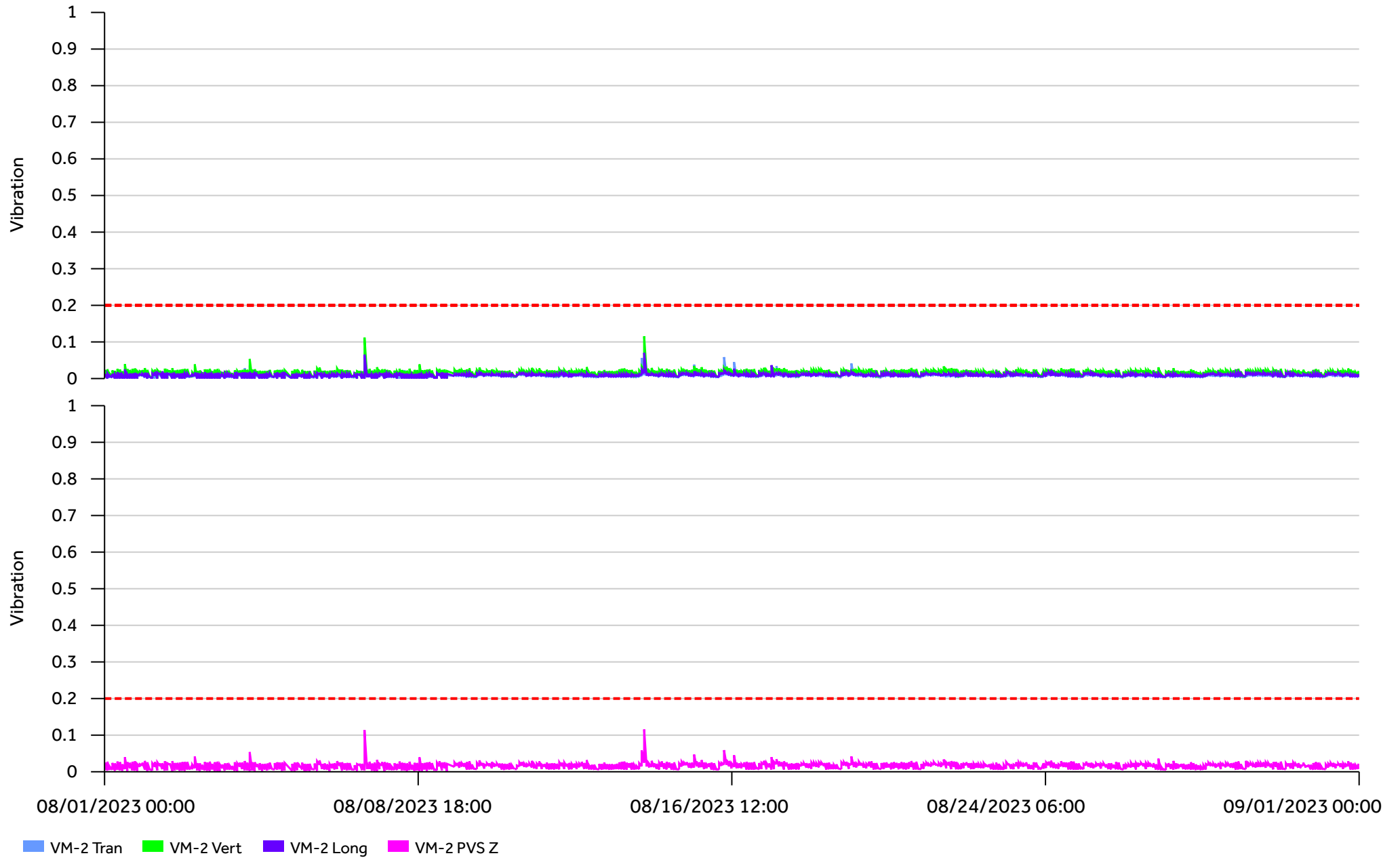
Observation Well Exceedances:

Observation wells do not have exceedance thresholds.

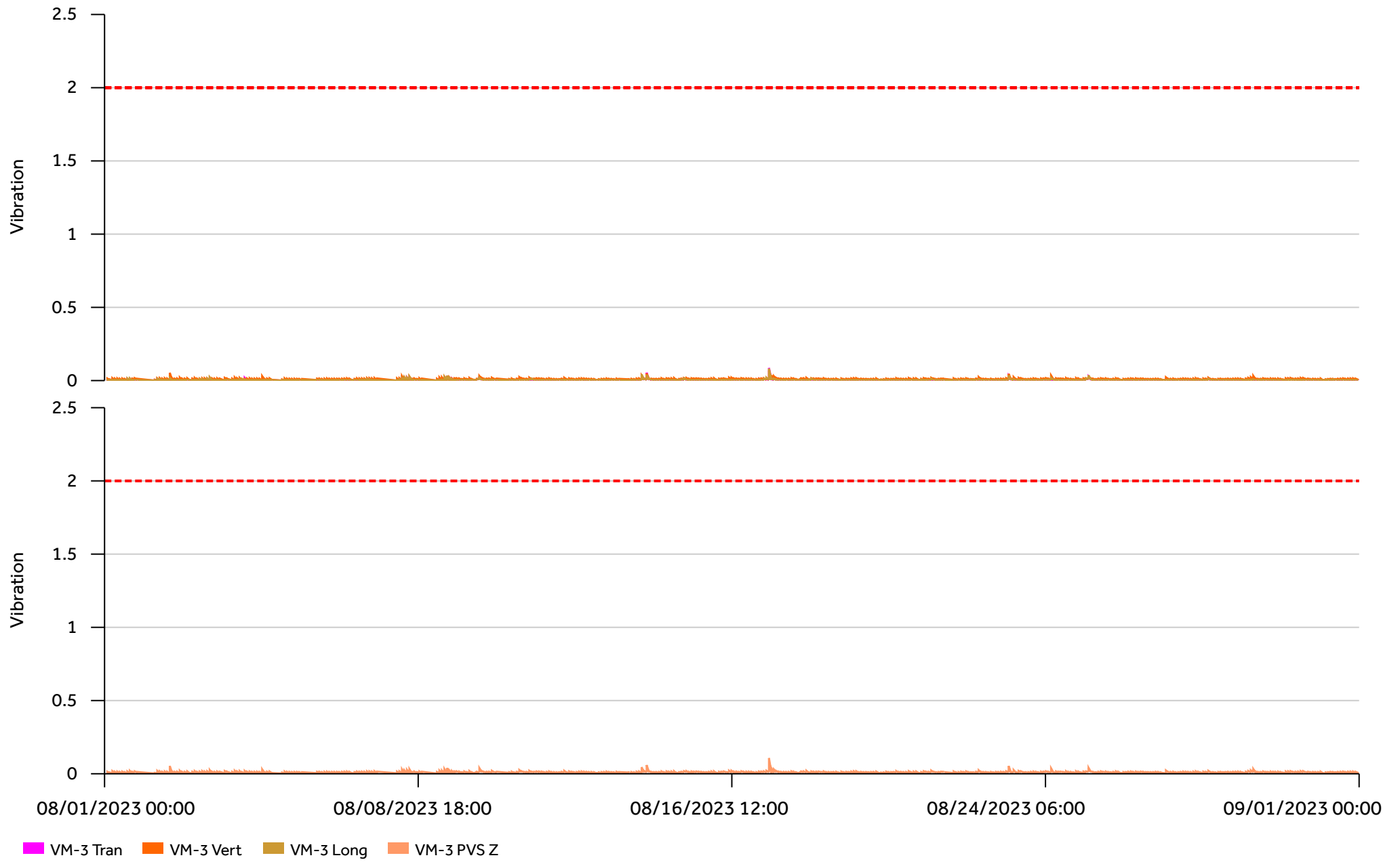
VM-1- Vibration Monitor

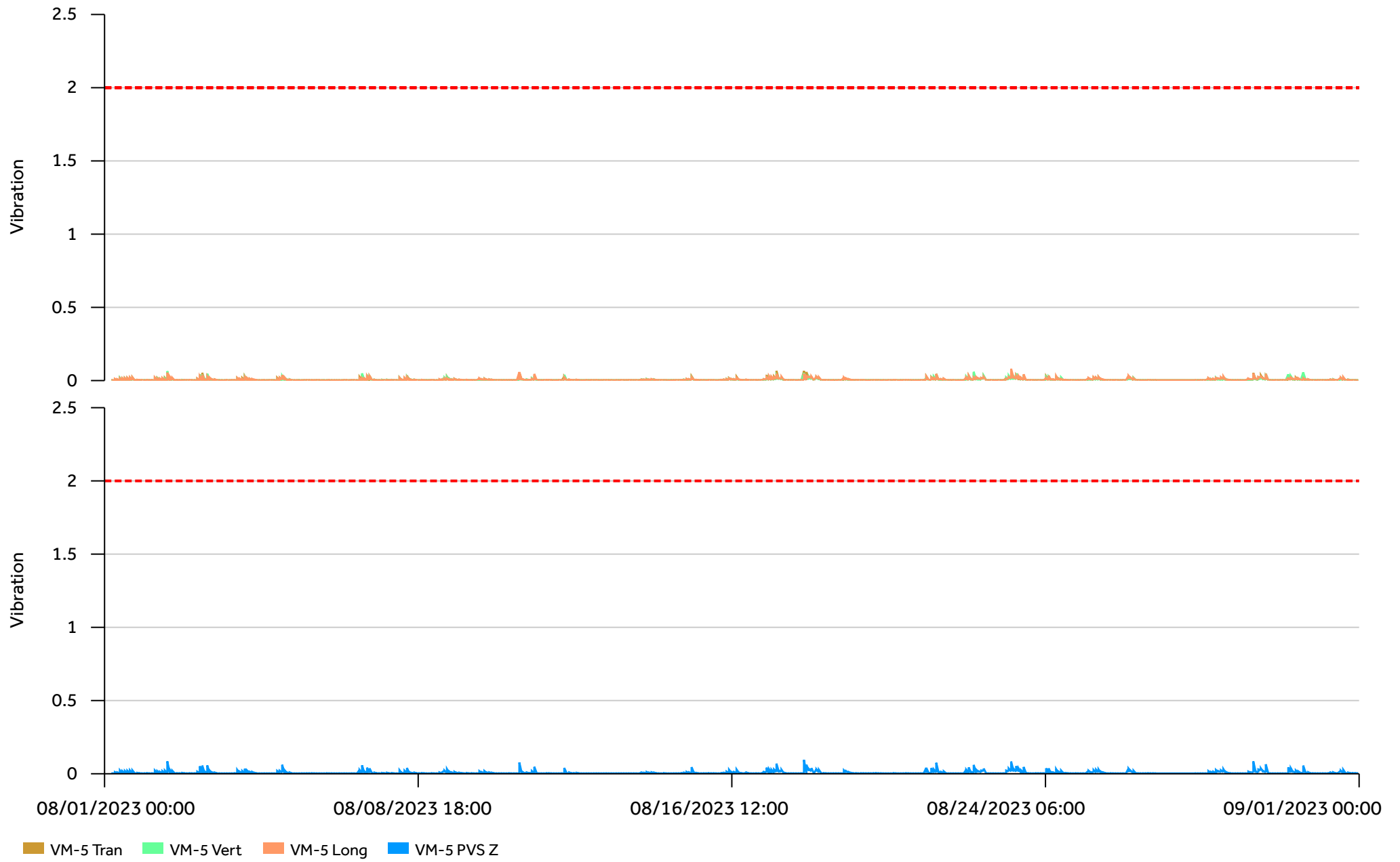
VM-3- Vibration Monitor



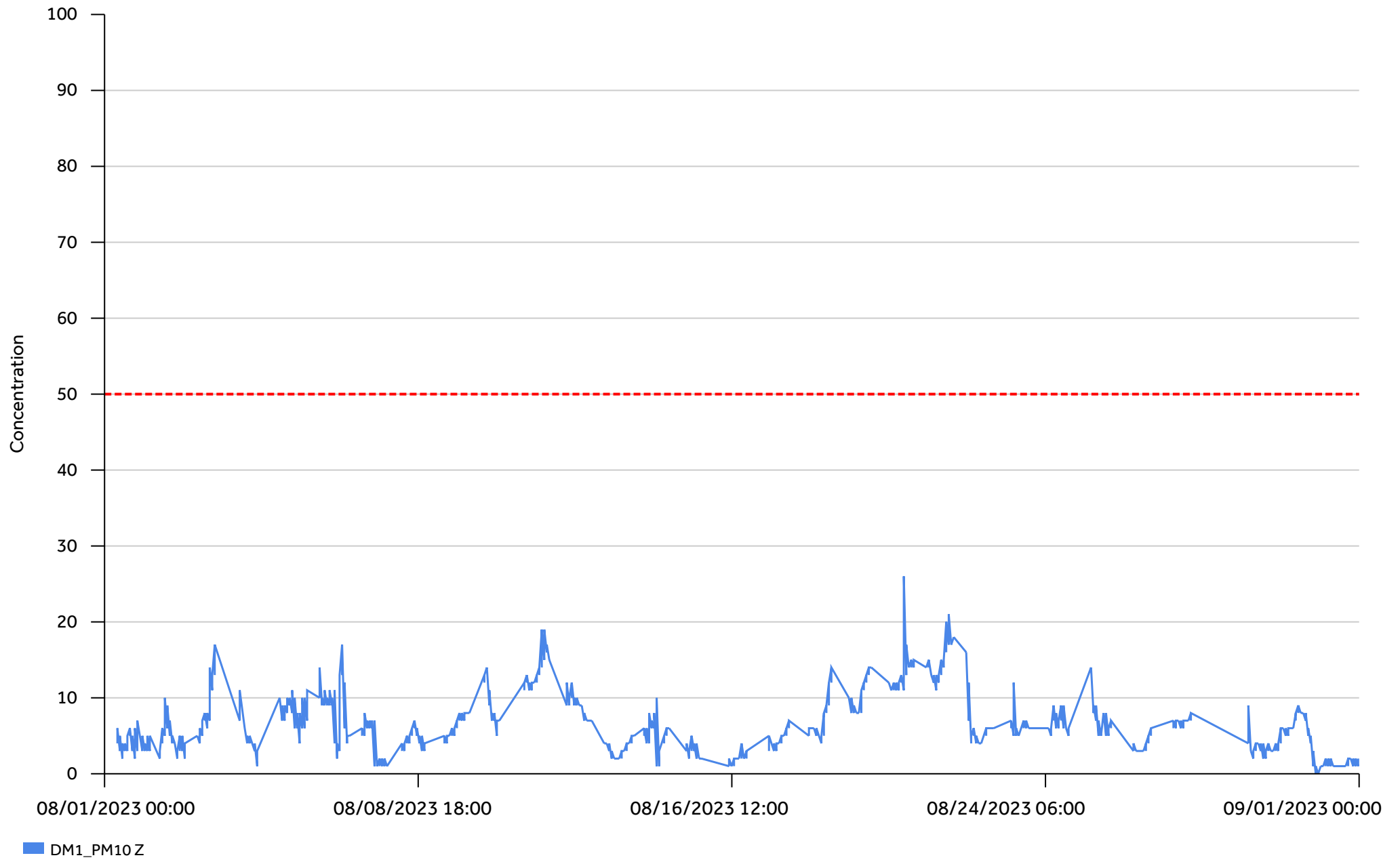

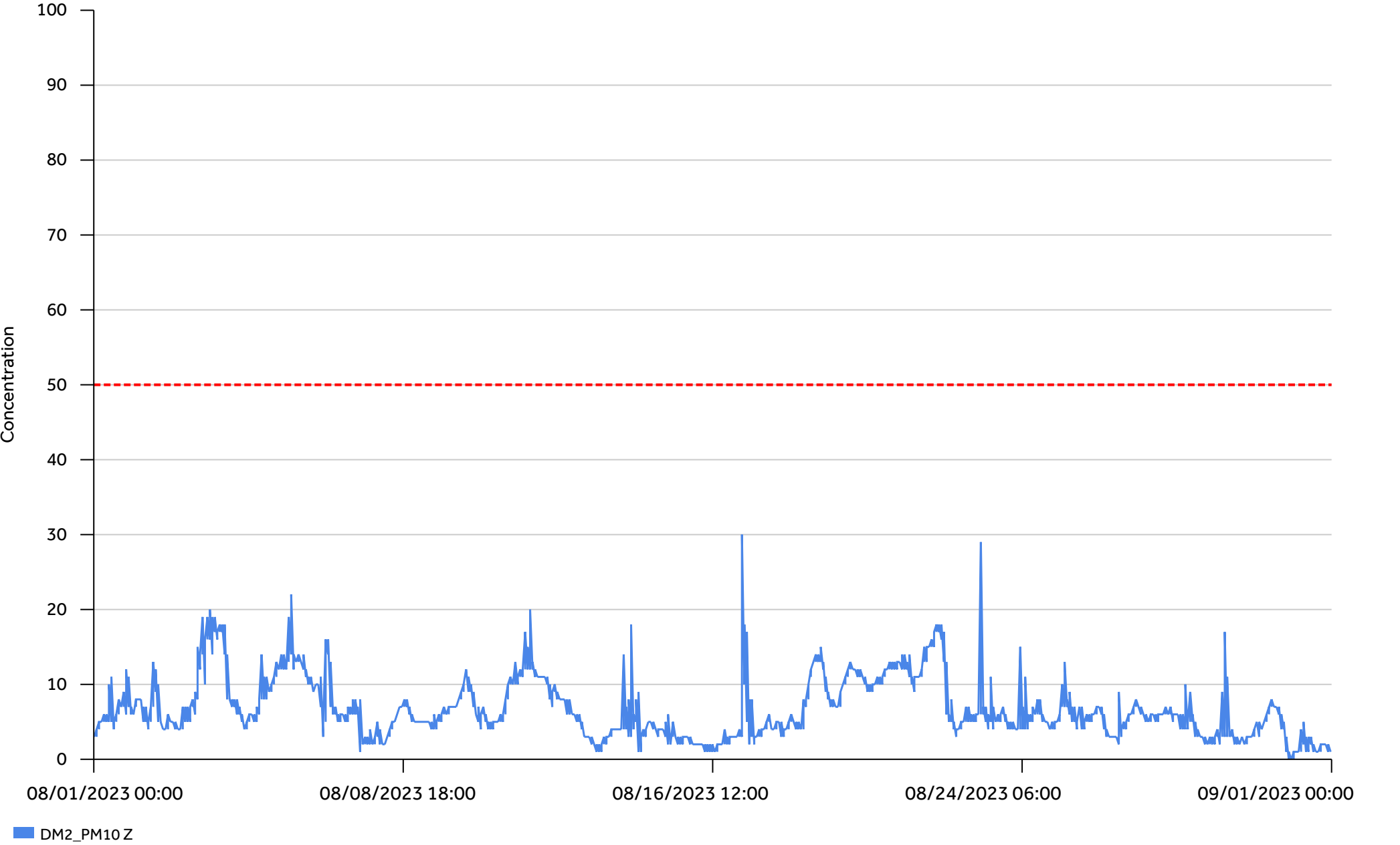

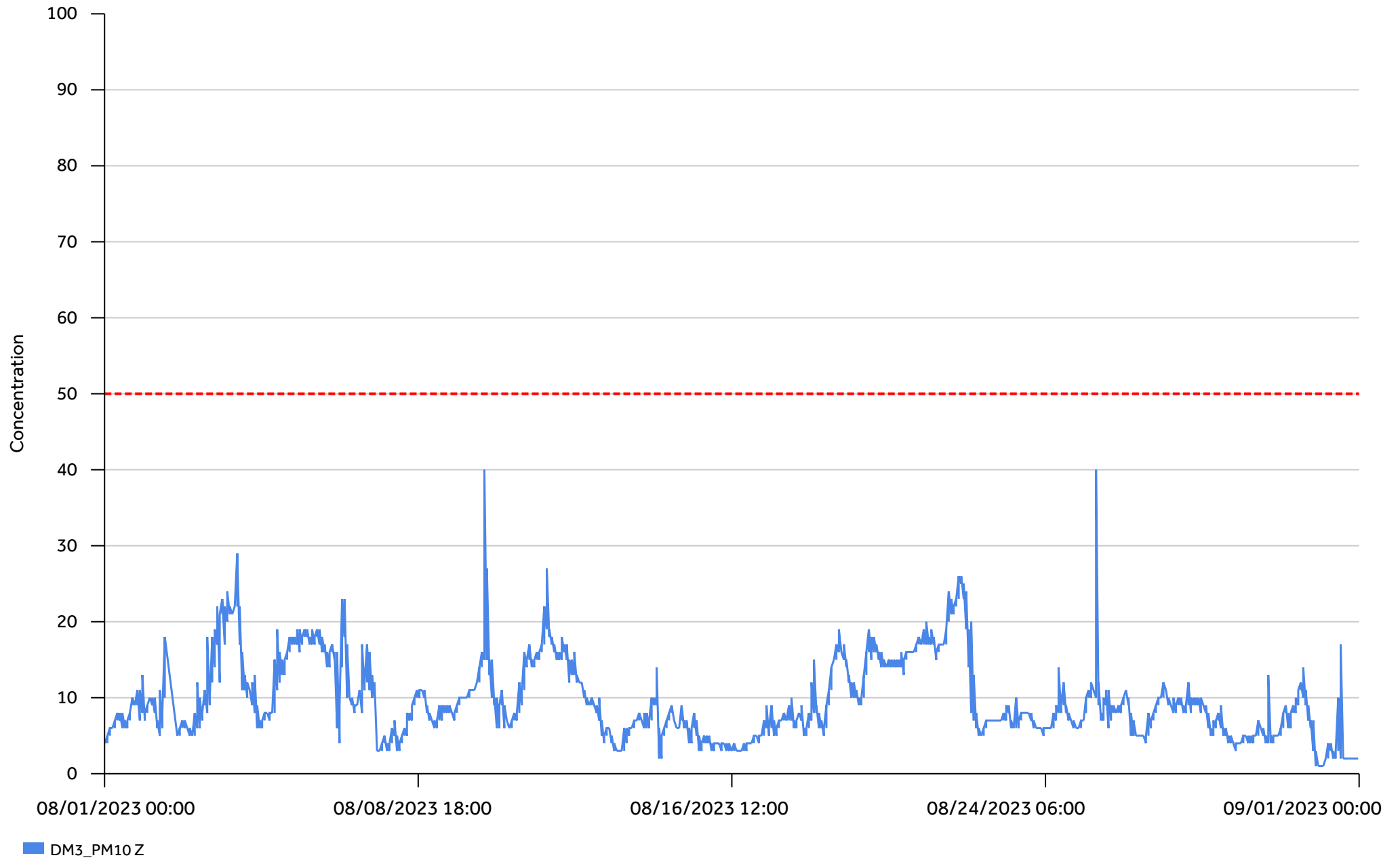
DM1 - PM10



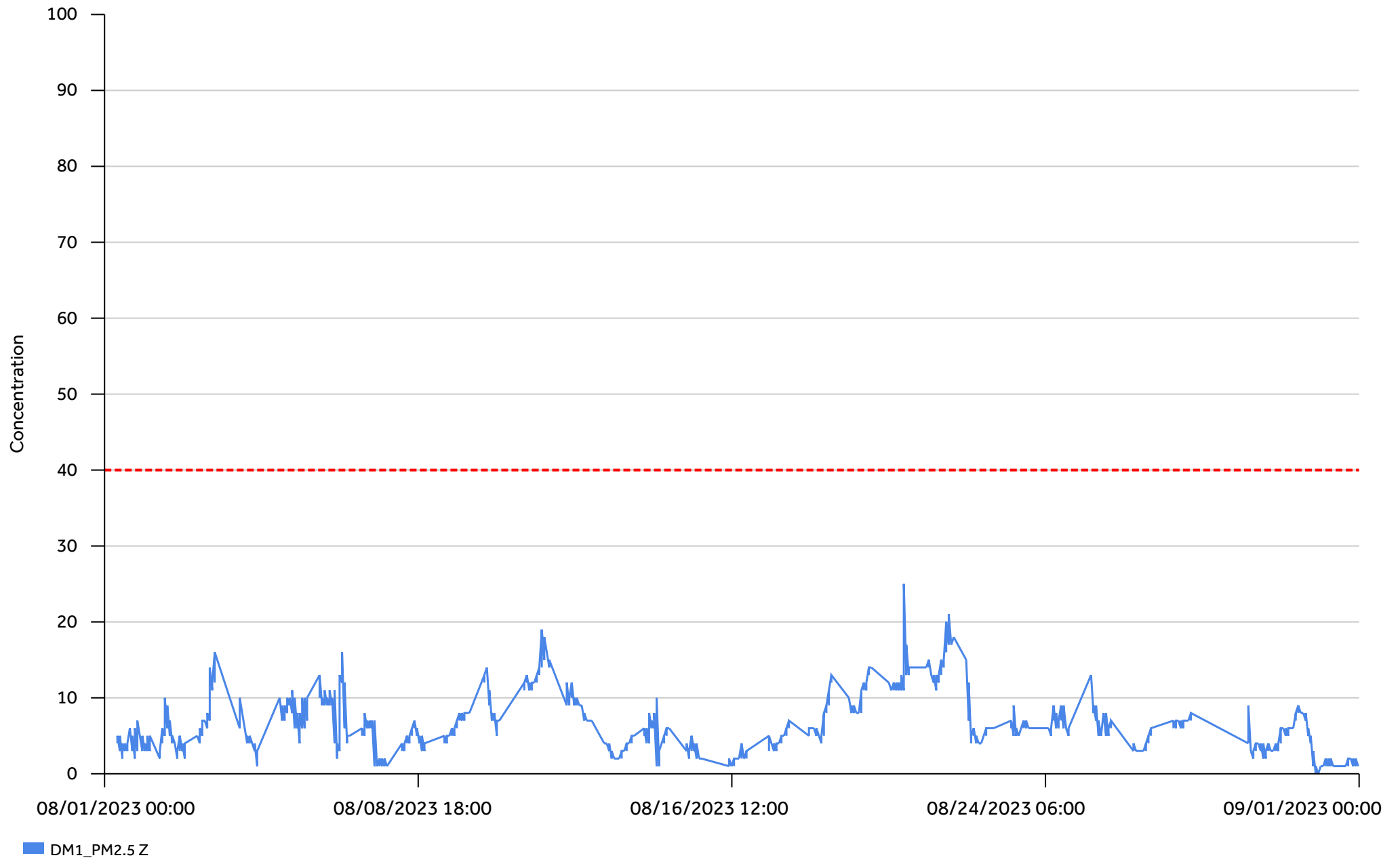

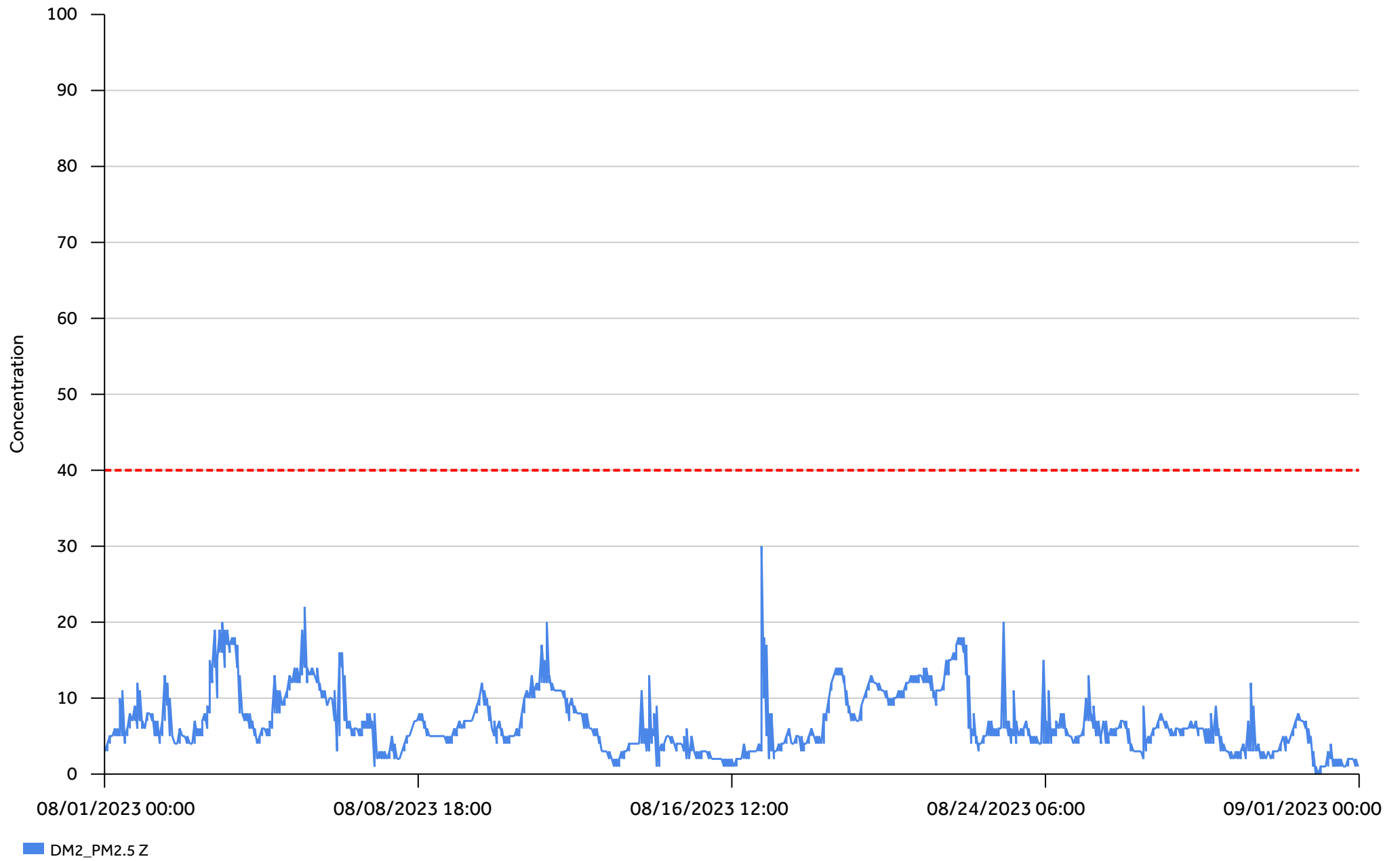
