This program provides for the complete rehabilitation of bus mechanical, electrical and structural systems when a bus is approximately 7.5 years of age. Additionally, the program supports the procurement of components to replace those that can no longer be overhauled.



Expected Outcome

Allows Metro to achieve the maximum useful life of a bus which extends the period between bus replacements while minimizing routine maintenance costs. Also, maintains bus reliability and addresses reliable revenue service availability as measured by the Bus Fleet Reliability performance indicator [FY21 target ≥7,000 miles between failures].

In Q2, Metro received 17 out of 100 bus rehabilitations, 31 out of 120 engine assemblies, 30 out of 150 transmission assemblies, 19 out of 140 fare boxes, and 2 energy storage systems. The initial target aimed for the annual rehabilitation of 100 buses; however, supply chain constraints and delays in FY23 impacted parts and equipment acquisition.

The initiative also involved the replacement of 3,490 track fasteners and the installation of 1,523 new third rail insulators. Renewal efforts extended to 25,841 linear feet of rail, ensuring the longevity and efficiency of the track system. Track surfacing activities covered an extensive 66,999 linear feet. Beyond these track-specific improvements, essential vegetation herbicide cutting was carried out to maintain track safety and cleanliness and increased drainage rodding capacity was a crucial focus.

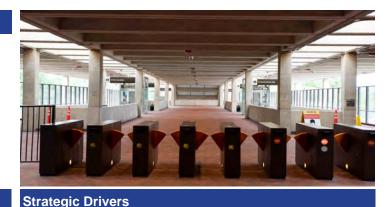

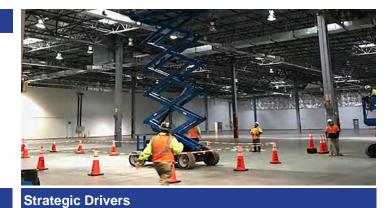

Additionally, the successful multi-year renewal of Oracle/Peoplesoft software licensing and support ensures the continued stability of these essential systems. The Edge Device Replacement process has been initiated and is progressing, with a focus on maintaining the currency and warranty of enterprise devices.

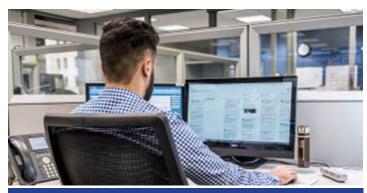

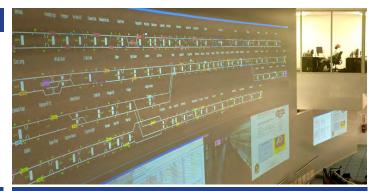

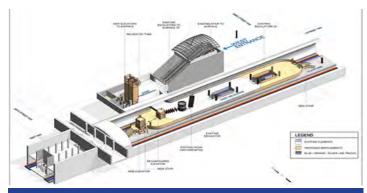

New Carrollton Station focused on civil activities, establishing a new parking lot section and enhancing sidewalk connectivity.
