






#### **Project Overview**

- Reconstruction of site includes:
  - New maintenance facility (Complete)
  - Parking for 292 buses
  - Charging infrastructure and equipment to support battery-electric buses (BEB)
  - Reduced fleet of 50 battery-electric buses
  - Parking structure for 420 employees
- Project Schedule:



# **Best Practices for Cleanliness & Noise Control During Construction**

- Required daily work area clean up
- Stationed waste receptacles (1)
- Department of Energy & Environment (DOEE) approved water runoff controls (2)
- Wash construction vehicle wheels
- Onsite street sweeper
- Weekly trash pick-up
- Typical weekday crew hours: 7 a.m. 7 p.m.
- Limited hours for oversized deliveries: 9:30 a.m. 3 p.m.











#### **Next Steps** for the Project

### November 2025 (planned)

- Structural & Architectural demolition of existing building (at east)
- Mechanical Electrical Plumbing (MEP) system demolition of existing building (at west)
- Mass grading on site (at west)
- Excavate & demolish existing stormwater detention system
- Demolish remaining hardstand

### December 2025 (planned)

- Slab/Foundation demolition (at east)
- Underground utility removal (at east)
- Structural & Architectural demolition for existing building (at west)
- Slab/Foundation demolition (at west)
- Underground utility removal (at west)
- Site utility demolition at north and east (e.g., storm line, manholes, waterline, sanitary line)

### January 2026 (planned)


- Slab/Foundation demolition (at west)


