#### TITLE:

Temporary Fare Reductions During Emergencies

#### PRESENTATION SUMMARY:

To request Board authorization for the General Manager/Chief Executive Officer (GM/CEO) to temporarily reduce or waive fares in cases of emergency, with a requirement to provide notification to the Board of such action as soon as practicable after the event.

#### **PURPOSE:**

To request Board authorization for the General Manager/Chief Executive Officer (GM/CEO) to temporarily reduce or waive fares in cases of emergency, with a requirement to provide notification to the Board of such action as soon as practicable after the event.

#### DESCRIPTION:

#### **Key Highlights:**

- Section 22 ("Temporary Reduction of Fares") of the WMATA Tariff authorizes the GM/CEO to temporarily reduce fares during emergencies.
- This proposed action authorizes the GM/CEO to implement temporary fare reductions or waivers without prior Board approval, but requires that the Board be notified of such actions -- including the estimated impact of the fare reduction on operating revenues -- as soon as is practicable after the event.

#### **Background and History:**

Section 22 ("Temporary Reduction of Fares") of the WMATA Tariff authorizes the GM/CEO to temporarily reduce fares during a declared emergency, including "an event occasioned by nature." The GM/CEO must seek Board approval for any temporary lowering of fares other than a reduction of fares from peak to off-peak.

Metro recently experienced two emergency situations in which the GM/CEO determined that transit fares and parking fees should be waived:

- The Metrorail and Metrobus systems were closed on January 23 and 24, 2016, as a result of the blizzard 'Jonas.' Limited service resumed on January 25, and Metrorail and Metrobus fares, as well as fees at Metro parking facilities, were waived on that day.
- Metrorail faregates were opened at certain Blue/Orange/Silver Line stations on

March 14, 2016, as a result of the cable fire at McPherson Square, and fees at Metro parking facilities were waived during the subsequent Metrorail system shutdown on March 16, 2016.

Both fare waivers were subsequently approved by the Board of Directors.

#### Discussion:

This proposed action will authorize the GM/CEO to reduce or waive any otherwise applicable fare or fee when faced with emergency conditions, for a period not to exceed 48 hours, and will require that the Board of Directors be notified of any such decision by the GM/CEO -- including the estimated impact of the fare reduction on operating revenues -- as soon as practicable after the event.

#### **FUNDING IMPACT:**

Update to GM/CEO authority has no immediate funding impact. Total passenger fare and parking fee revenue on a typical weekday is \$2.7 to \$2.8 million.

### Purpose

## Streamline GM/CEO Authority for Temporary Fare Reductions

- WMATA Tariff authorizes GM/CEO to impose temporary fare reductions in response to emergencies
- Board approval is required for any change other than reducing peak to off-peak
- Propose to allow GM/CEO to impose any temporary reductions or waivers (up to 48 hours) and then to notify Board
- Notification will include estimated impact on operating revenues



### Recommendation

## RESOLUTION OF THE BOARD OF DIRECTORS OF THE WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY

WHEREAS, Resolution 2003-58 and Section 22 of the Washington Metropolitan Area Transit Authority Tariff ("Temporary Reduction of Fares") authorizes the General Manager/Chief Executive Officer (GM/CEO) or his designee to temporarily reduce fares during a declared emergency, for a period not to exceed 48 hours; and

WHEREAS, This authorization requires Board of Directors' approval of any temporary fare reduction other than reducing fares from peak to off-peak; and

WHEREAS, Recent experiences have shown that at times it is appropriate for the GM/CEO or his designee to temporarily waive all fares and reduce or waive parking fees; now, therefore be it

RESOLVED, That the GM/CEO is authorized to reduce or waive any otherwise applicable fare or fee when faced with emergency conditions, for a period not to exceed 48 hours, and that the Board of Directors shall be notified of any such decision by the GM/CEO, including the estimated impact of the fare reduction on operating revenues, as soon as practicable after the event; and be it further

RESOLVED, That the GM/CEO will revise the Tariff as necessary to reflect these changes in policy; and be it finally

*RESOLVED,* That this Resolution shall be effective 30 days after adoption in accordance with  $\S$  8(b) of the WMATA Compact.
